## *Chapter 1*

### **Witnessing the “Mystery of Iniquity”**

I was reared in the traditional customs of a Protestant Christian family in America. I couldn't help but realize early on in my teenage years that the “sacred” religious traditions which we confessed to believe and practiced actually went contrary to the very commands and principles of the “Bible”.

How could my Christian parents confess to believe the Savior's teachings: the Commandments and the Prophets and then turn around and practice the same abominations of ancient Baal worship? This wasn't rational! Was I missing something here? How could all these Churches teach moral lessons from their “Bible” on Sunday morning, and then, without hesitation, submit to outright pagan holidays and rituals which brought down the wrath of heaven upon ancient Israel? Did my parents fall asleep during Sunday school class or something? This was utterly shocking to witness!

*“This people honors Me with their lips,  
but their heart is far from Me.” - Mark 7:6*

What was most disturbing to me was, as a child, I was subjected to sit through a “sacred” Christian religious ritual that was nothing less than gruesome and traumatizing,

*There I sat amongst all these supposedly moral and righteous church-going folk. The minister gave a speech about the sacrifice of “the LORD” and to prepare ourselves to receive “Communion”. The black-robed preacher man explained how this ritual was in the Bible. Then the big moment arrived. He said, “prepare to receive the Body of Christ”. From the looks on people’s faces, I couldn’t tell if I was supposed to be excited or not, but I did hear some lips smacking in the crowd.*

*“Settle down son, it’s going to be ok,” soothed mother. A plate bearing some flat crunchy crackers was passed along the pews to the silent crowd. We were told to believe “by faith” that these crunchy crackers were really the flesh and bones of our God, and unless we ate it we couldn’t get into heaven. How insane is that? But I was just a young lad. How was I supposed to know the difference between sanity and being a candidate for the funny farm? My parents wouldn’t give me a cracker. They said I was too young, that I didn’t understand. You got that right! After hearing the sermon about the Last Supper – feasting on flesh and blood that some disciples had to eat, I just wasn’t very hungry after that.*

*I noticed that some people had dropped a few cracker crumbs on the floor. I didn’t know if I should say anything about it. Would it mean that these church folk would be trampling on Jesus as they left the church? This whole thing just didn’t seem kosher to me. I wanted out of there, so I tried making a dash for the back door.*

*“Sit still there and hush now!” – scolded mother. It was no use. I was trapped. Oh boy, things were about to get a lot worse! After everyone finished crunching on their little cracklin’ “Christos” crackers, I saw the black-robed man preparing to pass around little cups o’ blood! Yikes! But I didn’t want to drink blood!*

*“Quiet down son! Show some reverence for the LORD!” scolded mother again. I beheld an expensive silver tray bearing little shot-glasses filled with a red juicy liquid – the “juice of Jesus”. All the sudden, I got a strange queezy feeling down in my stomach. I sat trembling – the hair standing up on the back of my neck as I watched My parents each take the little shot-glass, hold it to their lips, and then after a slight hesitation (as if their conscience was telling them “don’t do it!”) they slurped down the “blood”. Was I caught in the Twilight Zone...or was I in the nuthouse? This reminded me of that vampire movie I had seen the night before. Was it easy pretending to drink blood? My parents just went along with all this make-believe hocus-pocus stuff, just as they pretended about the Tooth Fairy, the Easter bunny and Santa Claus. Hey, if I pretended hard enough, as they seemed to, could I make a brand new bike appear?*

*How could anyone actually enjoy “pretending” to drink blood? If this experience wasn’t enjoyable, why were they being coerced into doing it? Does the Savior really blackmail his people into “eating his flesh and feasting on his blood” in order to get into “heaven”? I thought cannibalism was against one of those commandments in the “Bible”. Oh, it was only grape juice? Then why would they say it was the blood of god? If pretending was so important, why didn’t they just skip the mental theatrics and just drink the real thing – say like chicken or cow’s blood from a slaughter house? Wouldn’t that make “pretending” a lot easier? This communion thing just didn’t seem kosher. It made heaven look kinda scary to me! What was this “heaven” really all about if initiation meant crunching on bones and slurping-down blood like a vampire? And they say hell is a scary place!*

*(Through the eyes of a child - age 11)*

The inconsistencies and contradictions practiced by the Church became too horrifying for my young mind to handle. How is a child supposed to process this disgusting ritual of cannibalism? If Christians say “*eating the flesh and blood*” of their god is good, then how is cannibalism bad? Was there anyone else noticing this spiritual paradox? What was I to do? Should I “dare” question a global religious system that controls almost half the world’s population? I had to make some sense of this conflict, or I’d go insane!

Not having the maturity at the time to understand what I had experienced, I just suppressed this biblical contradiction. It wasn’t until my college years that I broke free of this dangerous religious phenomenon. The loving Creator Yahweh designed a universe with such mathematical precision and intricate beauty. I knew only my Maker Yahweh could give me a logical explanation behind this mysterious psychotic behavior that had afflicted my family and those of Christianity. Abba Yahweh gave me an answer to my dilemma within the verses of the book so many confess to believe,

“*But seek you first the Kingdom of Yahweh and His righteousness, and all these things will be added unto you.*”  
– Matthew 6:33

When the truth of Yahweh is your #1 priority, He gives you the “eyes to see” what the world cannot see! His Name brings the light that opens your spiritual eyes! His Name really is the “password” into His truth and revelation! Yahweh showed me that this insane spiritual phenomenon that I was witnessing was really the “*mystery of iniquity*” (2 Thes.2:7) being fulfilled in real time right before my very eyes! And this was the result and fulfillment of Revelation..

“*... Satan, who deceives the whole world!*”  
- Revelation 12:9

Could this powerful spirit being actually deceive the world on such a massive scale? Was *pagan* Christianity foretold about in the numerous prophecies of Scripture? For me, the answers to these questions became the defining issues behind the true character of the so-called “Christian Faith” and whether I would follow in its strange pagan traditions!

How advanced is a so-called “Christianized” society which demonizes those who dare question or criticize its “sacred traditions”? I have learned that questioning the doctrines sacred to the Church - is something which priests and pastors cannot AFFORD to tolerate. In the past, any independent, objective, even scientific inquiry was forbidden and evoked the dreaded Inquisition of the Roman Catholic Church across Europe. Thousands of Protestant Reformers and their followers were persecuted and burned at the stake for daring to disagree with the doctrines of the Church, as well as for simply wanting to just read the “Bible”.

Today, the religious oppression might not yet be that overt in America, but from my experience, not even professors at prestigious “Christian” colleges and universities will even dare to entertain such bold new information being discovered and shared by Two Witness Ministries. I think they are afraid that the truth will lead to their unemployment. What does that say about the pagan propaganda spewing from these institutions of “higher learning”? The cover-up of the facts of Rome’s paganization of the Torah Faith of the Hebrew Savior is a terrible injustice against honest, sincere, truth-seeking people everywhere. This confirms prophecy,

*“Yes, truth is suppressed; and he who departs from evil is accounted as insane!” – Isaiah 59:15*

As the prophecies confirm, there is NO revival for Truth taking place in the churches today! NO revolution from the bondage of pagan sun worship on any Christian


college campus in America today, except for the rush to protect the sacred traditions of the Church! As the defiant “Reverend Circe Nixon” proclaimed, “*The truth must be managed and suppressed to protect our sacred traditions!*”

The Meshiakh witnessed the same religious psychosis afflicting the Pharisees and teachers of His day as well. With every passing pagan holiday, I wonder if Christians will wake up from their fairy-tale religion. It reminds me of the movie, “*They Live*” wherein it required special eye-glasses to see that the planet was being overrun by alien beings. In order to ensure a successful takeover of planet Earth, church priests and pastors (taking the role of these alien beings) with flattering speech and sophisticated religious double-talk trick and deceive the sheeple into practicing Baal worship, dutifully paying “tithes” to continue the lies. Eventually, the sinning population of earth destroys itself under Yahweh’s righteous judgments, and the takeover of planet earth is complete. Is human nature that gullible?

Now, in real time, Church leaders have convinced their flocks to support the endless “War on Terror” campaign all “in Jesus’ Name”! As the White House’s “National Security Strategy of 2002” suggested, Christians should support pre-emptive military attacks and outright invasion upon

“suspected” terrorist nations and carpet bomb into oblivion all the sovereign oil-rich Islamic nations of the Middle East - all “*in Jesus’ name*”! Starting “Wars and rumors of war”... in the name of “peace and safety”! (Jer.6:14-15) Prophecy shows this leads to World War III (the Four Horses of Revelation 6 and the killing of millions of people. *Hellooooo!- Is anybody home!* Are aliens running the planet?



As the body count of innocent Iraqi civilians mounts, as violent and degrading torture tactics by US troops goes unpunished, as depleted uranium-DU munitions by US troops permanently destroys the environment of the Middle East (even US troops contracting fatal radiation induced cancers & spreading it among family members upon return) the

Church remains ardent supporters of endless war. The Church is king George W. Bush’s largest support base!

*“...saying, Peace, Peace, when there is no peace. Were they ashamed when they had committed abomination?*

*NO! They were not at all ashamed.”* - Jeremiah 6:14-15

(For more information on President Bush’s fulfillment of last days

prophecy, request, “The Rider of the White Horse – George W. Bush in Prophecy!” World War III is now inevitable!)

I thought the Savior instructed His people to live righteously practicing true love and peace? But War? Easter eggs? Christmas trees? Ghosts and goblins with memorials to the dead on Halloween? These are contrary to the teachings of the Savior! These are contrary to the Torah-based teachings of the first century Hebrew Apostles! The Savior Meshiakh labeled this counterfeit religion of iniquity and sin:

**“MYSTERY BABYLON THE GREAT”!**

Who then is actually spiritually blind?...those who, without question, blindly follow their cult leader, be it: Jim Jones, Jim Baker, Jimmy Swaggart, Jerry Falwell, Kenneth Hagen, Kenneth Copeland, Paul Crouch, Billy Graham, Pat Robertson or the Pope?...Or those who seek out the truth to “prove all things” as instructed by the Apostle Shaul to his Thessalonian congregation? (1 Thes.5:21) Facts are Truth.

*“Deliver us from the workers of iniquity,  
and save us from bloodthirsty men!” – Psalms 59:2*

After years of study and a personal journey of living the Faith of the Savior, I have come to realize that my Savior the resurrected King—the Hebrew Messiah of 2000 years ago, is still rejected (Isayah 53:3), not just by Jews, but by the Church that claims to “come in his name”!

*“Many will come in my name...and deceive many.”*  
- Matthew 24:5 (KJV)

These words still ring true today - are you surprised? This is the only rational explanation for the Baal worship of the Church. Here’s another prophecy still holding true,

*“Yahsha said to them, Have you not read the Scripture:  
The stone which the builders rejected, has become the chief  
cornerstone of the foundation. This is Yahweh’s doing,  
and it is marvelous in our eyes” – Mark 12:10-11*

The Church rejects obedience to the Torah-based teachings of the Hebrew Messiah of Israel, and therefore, rejects the Savior Himself! This Savior is Yahweh’s Son – Yahsha Messiah the anointed cornerstone. Those who do not obey His Torah commands, *do not know the Savior!*

*“Now by this we do know that we know Him if we keep His Torah commands. He who says, I know Him, but does NOT keep His Torah commands, is a LIAR, and the truth is not in him.”*

– 1 Yahchanan/John 2:3-4

How do we know He is still rejected? Because by their “works”, allegiance, and pagan worship they bring honor to the elohim – the gods of the ancient pagan world – the solar deities of Egypt, Babylon, Greece and Rome!

*“Then the children of Israel did evil in the eyes of Yahweh, and served the Baals, the gods, and goddesses. They forsook Yahweh the Strength of their forefathers, Who had brought them out of Egypt; and they followed and worshiped the various elohim of the peoples around them. They provoked Yahweh to anger, because they forsook Him and worshiped Baal (the LORD) and Astarte the goddess (Ashtoreth, Ishtar, Easter). Then the anger of Yahweh burned hot against Israel. So He delivered them into the hands of raiders and thieves who plundered their property and possessions. He sold them into slavery into the hands of their enemies all around them, so they could no longer withstand their enemies. Wherever they went out to fight, the hand of Yahweh was against them to defeat them... ” – Judges 2:11-15a*



In “EASTER”, the most important celebration of the “Christian” calendar, we have the very name of the ancient sex goddess of Babylon! Behold, she even holds their precious Easter lily!

*“Ashtoreth: a Canaanite goddess identified with the planet Venus. The name is cognate with the Babylonian Ishtar (**Easter**) goddess of sensual love, maternity and fertility. Licentious worship (prostitution) was conducted in honor of her...her polluting cult even presented danger to early Israel (Judges 2:13; 10:6). Even Solomon succumbed to her voluptuous worship (I Kings 11:5; II Kings 23:13).”* - Unger’s Bible Dictionary, p.412

In Canaan, this mother goddess was “Astarte”; in Phoenicia “Ashtoreth”; in Persia and Babylon she was “Ishtar”, and in modern Christian America she is “Easter”. This goddess is that same mythological whore invoked by devout “Christians” every spring! Yahweh’s righteous instructions include NEVER invoking the names of such pagan deities (Exodus 23:13). These are the traditions of the Church - forbidden pagan practices we find throughout the Law and Prophets of every “Christian Bible”! This ancient “Queen of Heaven” is still adored in the springtime with her Easter lilies and brightly-colored fertility eggs which drop down from her heavenly ovaries on the lawn for little “Christian” children to find and eat!? *Rituals of Babylon!*

Just as in ancient Babylon and Canaan, from atop their temples, Churches erect heavenward her sacred occult objects: phallic obelisks, today called “church steeples” to honor her sexuality. Church steeples are also condemned in the Torah (Deut. 12:2-4; 1 Kings 15:13) These idolatrous images supposedly aided in her fertility to renew life on earth and hopes of another bountiful harvest and large herds for all her faithful worshipers...including Christians?

Yahweh severely judged ancient Israel for their worship of Easter in hopes that “Christians” in the latter days would learn from their mistake and repent from this grievous sin.

The English translators of the King James Version of 1611 (KJV) must have also been devout worshipers of Easter for they were responsible for inserting her detestable name into the New Covenant Book of Acts, chapter 12, verse 4, (Violation of the Torah Law from Exodus 23:13, Psalms 16:4, and Deuteronomy 12:32) which reads,

*“And when he had apprehended him, he put him (Kepha the Apostle – erroneously named ‘Peter’) in prison, and delivered him to four quaternions of soldiers to keep him; intending after **EASTER**\* to bring him forth to the people.”* - Acts 12:4, Authorized King James Version

(\* properly translated **Passover** (*Heb. pesach*). Modern publishers & printers of this “Authorized Version” even admit to this blasphemous error by the mistranslators of King James.)

We have plainly seen proof of Easter -the name of Babylon’s fertility “Queen of Heaven”. The manipulation of Acts 12:4 was purposeful and paid homage to the Sun-worshiping Roman emperor Constantine I, who decreed the pagan observance of Easter instead of Passover at the Council of Nicea, 325 ce. (Funk & Wagnall’s Standard Encyclopedia, Vol.8) This is just one of the numerous errors and blasphemies found within the version authorized by a well known sodomite: King James I. This is the version which fundamentalist “Christians” blindly defend as the “infallible Word of God”. (*Can we conclude that “God” agrees with the pagan fertility rituals offered to the goddess Easter?*)

Why aren’t “Christians” throwing out the King James per-version which so blatantly alters the “New Testament” scriptures?! By their silence, aren’t “Christians” agreeing

that the “Word of God” can be altered, manipulated and changed to bring agreement with their sacred traditions? It appears so. Every spring, Christian parents urge their little Christian children to continue the ancient Babylonian tradition of finding and collecting the colorful eggs of Easter- the sex goddess of Babylon! The English KJV is littered with such filth. Where is the outrage against this blasphemy!

**Question:** Do you know from whence comes the word “Church” which the English translators so frequently used throughout the King James Version in describing the congregation or assembled people of the Meshiakh?

Again, most “Christians” don’t know the truth behind this answer because the tithe-hungry wolve\$ in the pulpits don’t encourage such study into history nor the law of righteousness! The name of the goddess EASTER is found only once in the Book of Acts (12:4). This mistranslation causes “christians” to blaspheme less frequently. “Easter” is bad enough but is NO MATCH for the “Level-10” blasphemy of the word “Church”! This isn’t just a harmless word – it’s derived from a NAME! The name of a powerful sorceress and spell-casting witch from Greek mythology! (Deut.18:10-12) Pay attention to Yahweh’s instruction for all Christians,

*“In all things that I have said to you, be on guard and do them, and make NO mention (in your worship) of the names of elohim-the gods, neither let them be heard from your mouth.” – Exodus 23:13*



**CIRCE** - the daughter of the Greek sun god Helios and Perseis (the daughter of Okeanos). **Circe/Church** was a goddess Pharmakeia (Sorceress/Witch) who lived with her Nymphai attendants on the mythical island of Aiaia. She was skilled in the magic of metamorphosis, as well

as the power of illusion, and the dark arts of magic potions and necromancy. Her name is also the origin of the “circus” in honor of her parade of entertaining animals.

### From Homers Odyssey,

*“On her island... in her palace... Circe waits for lost sailors to come wandering to her door as supplicants. Odysseus and his desperate crew went ashore on the island of Aiaia hoping to find food and water. Odysseus sent twenty three men to explore the island but only one returned. As the men walked from the beach they could hear sweet singing from Circe’s home in a forest glen. Wild lions and wolves (drugged by Circe) came, wagging their tails, to greet the strangers. They were charmed by her beauty and drank the potions she offered as refreshment. As Circe’s vile drugs took effect, the once valiant men began to change shape and were soon fully transformed into swine. Circe herded them into pens and threw pig food on the ground before them... Then, Circe made a potion for me (Odysseus) to drink and gave it in a GOLDEN CUP, and with evil thoughts in her heart added the drug to it. Then when she had given it and I drank it ..., with-out being enchanted, she struck me with her wand and spoke and named me: “Go to your sty now and lie down with your other friends there.” (Christians enter her temple, drink her golden cup, and have fallen under her spell, being turned into spiritual swine!)*

- Revelation 17:4



In the original 1828 Webster's Dictionary, we find that the word CHURCH derived from the Anglo Saxon “*Circe*” – an evil witch and sorceress!

**"Church, n. [Anglo Sax. *CIRCE*, circ or cyric; Scots, kirk, which retains the Saxon pronunciation; D. Kerk; G. Kirche; Se. Kyrchia; Dan. Kirke; Gr. Kuriokon, a temple of God, from kuriakos, pertaining to a Lord, or to our Lord Christ, from kurios, a Lord; Russ. Tzerkou.] 1. A house consecrated to the worship of God, among christians; the Lord's house."** (pagan temples!)

In all various European languages, the name of the Christian house of worship derives from the name of this witch from ancient Greek mythology Dutch: Kirke; German: Kirche; and the English: CHURCH!

The first entry as to the etymological meaning and origin of the church is "CIRCE." Now for those who are versed in Greek, this connection to Greek mythology was so obvious and embarrassing that Mr. Webster did not put this noun in his dictionary, but he did put the adjective which is under "Circean", we find the following definition:

*"adjective; Pertaining to CIRCE, the fabled daughter of Sol and Perseis, who was supposed to possess great knowledge of magic and venomous herbs, by which she was able to charm and fascinate."* Webster's Dict., 1828



## Protestant translator rejects “Church”!

Church (Old English *cirice* CIRCE; Middle English...  
*chirche*; whence *churche*, etc.: Greek *kuriakon*)

Webster’s New Collegiate Dictionary, 1981 confirms...

CIRCE: a sorceress from Greek mythology who changed Odysseus’ men into swine...

Yahweh’s people are instructed to NOT invoke the names of any pagan deities! Yet the King James Version and its Christian adherents hold no restraint under such righteous instructions from heaven. Satan, through his Circe-Church seeks to turn all “Christians” into swine by drinking this witch’s brew of false doctrine from her Golden Cup - *Communion!!* This witch is listed over 100 times in the English King James per-Version of the “Bible”. *53. Then (Jesus) said unto them, Verily, verily, I say unto you, Except ye eat the flesh of the Son of man, and drink his blood, ye have no life in you.*

*54. Whoso eateth my flesh, and drinketh my blood, hath eternal life; and I will raise him up at the last day.*

*55. For my flesh is meat indeed, and my blood is drink indeed.*

*56. He that eateth my flesh, and drinketh my blood, dwelleth in me, and I in him.*

*57. As the living Father hath sent me, and I live by my Father; so he that eateth me, even he shall live by me.*

*58. This is the bread which came down from heaven; not as your fathers did eat manna, and are dead; he that eateth of this bread shall live forever.*

This cannibalistic theme of Communion can be found **NOWHERE** in the Law or the Prophets! The Torah Covenant instructs Israel to NEVER drink the “life blood”, but to *POUR IT OUT* at the base of the altar. Why would the Hebrew Meshiakh institute cannibalism as a remembrance ceremony for His death, when He didn't die by cannibalism? **April 27, 2006** -- Standing in front of a group of high school students on the outskirts of Dallas, a man named

Nando Parrado had an unusual lesson in life and death to share.

"Can you imagine how terrible and slow and horrible is the death sitting down, freezing and looking to your friends," he asked them.

Parrado shared his story in an exclusive interview with "Nightline" and Outside Magazine.

"Let's say that I could close this room, put the temperature to 30 degrees below zero, no lights, nothing ... and let's wait. There's nothing to eat. Who would die first?"

For Parrado this was no mental exercise. He experienced this. His story began on Friday the 13th in October 1972, when he was 22 years old.

That day Parrado and his teammates from the Old Christians Rugby Club (emphasis mine) boarded a chartered flight from Uruguay to Chile.

...The flight followed a course across the snow-covered Andes. But at an altitude of 14,000 feet, and some 250 miles off course, it crashed into the mountains.

At such an altitude there was no vegetation that they might be able to consume as food. All that was left in the cabin were some chocolate bars, chocolate-covered peanuts, jam and discarded wine. And temperatures were so severe — minus 35 at night — that it took ages for the ice to melt so that they could drink water. Incredibly, they survived for seven days on the minuscule morsels.

But soon the terrible reality hit them. If they did not find some food, then they would all die of starvation. In a sudden and shocking moment, resistance to the final taboo of any modern civilization was breaking down.

"I think that the first thought of surviving in a way that breaks all the taboos of civilization, eating human flesh, starts to creep in your mind around the seventh or eighth days after the last chocolate-covered peanut was finished," he said.

"I was there lying at night and suddenly this thought comes into my mind. The only thing we can do is eat the dead bodies of our friends. But, I thought, if I'm thinking this, all the other guys, they are like me, they must be thinking the same thing."

### **Rescue Effort Called Off**

The following day, the remaining survivors had an open discussion and entered into a pact. That they would eat the flesh of their friends who'd perished in the crash and cold. One of the players, who was a medical student, was charged with dissecting the flesh. Their desperation for survival had transformed them into cannibals...

This tragedy inspired the ABC tv movie, "Alive".

### **The Church Requires “Blind Faith”**

Cannibalism is, of course, the eating of one's own species. It can be distinguished from [vampirism](#), which is the drinking of human blood. If you cut a fellow human up into little pieces and puree him or her in a good blender, that would technically be cannibalism and not vampirism.

There are two kinds of cannibalism -- sociological and pathological. The former means living and eating in a culture where cannibalism is accepted, and the latter means practicing cannibalism within a culture where it's not accepted. How then would the Church classify its religious ritual of cannibalism? Clearly, Communion is both sociological

and pathological for the Church requires their “divine feast” of flesh and blood (in symbols) to reach “heaven”, while at the same time condemning physical cannibalism.

Christians believe in “blind faith”, meaning: *without question*, that religious cannibalism is acceptable because it SUPPOSEDLY was the teaching of the Savior of the world. Could this really be true? You will soon understand how and why this is absolutely false and an outright lie from Babylon!

Have you ever considered how horrifying and traumatic traditional “fairy tales” could be on young children? Why are these “stories for children” filled with themes of cannibalism? In ***Jack and the Beanstalk***, Jack is on the run from a giant who wants to violently “grind his bones” for dinner: *‘Fe, fa, fi-fo-fum, I smell the blood of an Englishman. Let him be alive or let him be dead, I'll grind his bones to make my bread.’* This is traumatizing!

What about ***Hansel and Gretel***? The social taboo against cannibalism is engrained in the minds of children at a young age, and the following fairy tale has been one of those effective tools to get that gruesome point across. Here is an excerpt from this story designed for young children...

“...The old woman had only pretended to be so kind. She was in reality a wicked witch, who lay in wait for children, and had only built the little house of bread in order to entice them there. Then she went to Gretel, shook her till she awoke, and cried, "Get up, lazy thing, fetch some water, and cook something good for your brother, he is in the stable outside, and is to be made fat. When he is fat, I will eat him." Gretel began to weep bitterly, but it was all in vain, for she was forced to do what the wicked witch commanded.

And now the best food was cooked for poor Hansel, but Gretel got nothing but crab-shells.

Every morning the woman crept to the little stable, and cried, "Hansel, stretch out your finger that I may feel if you will soon be fat." Hansel, however, stretched out a little bone to her, and the old woman, who had dim eyes, could not see it, and thought it was Hansel's finger, and was astonished that there was no way of fattening him. When four weeks had gone by, and Hansel still remained thin, she was seized with impatience and would not wait any longer.

"Just keep your noise to yourself," said the old woman, "it won't help you at all."

Early in the morning, Gretel had to go out and hang up the cauldron with the water, and light the fire. "We will bake first," said the old woman, "I have already heated the oven, and kneaded the dough."

She pushed poor Gretel out to the oven, from which flames of fire were already darting. "Creep in," said the witch, "and see if it properly heated, so that we can put the bread in." And once Gretel was inside, she intended to shut the oven and let her bake in it, and then she would eat her, too.

But Gretel saw what she had in mind, and said, "I do not know how I am to do it. How do I get in."

"Silly goose," said the old woman, "the door is big enough. Just look, I can get in myself," and she crept up and thrust her head into the oven. Then Gretel gave her a push that drove her far into it, and shut the iron door, and fastened the bolt. Oh. Was the purpose of this story to introduce the evil of cannibalism to young children? Since it was a witch that practiced the cannibalism of young children, then, therefore, cannibalism must be very very bad... *right?*

The painting makes you feel as if you just came around the corner and interrupted Saturn in the middle of his devious plan to devour his children. The painting depicts a pagan myth. The myth roughly follows: Saturn understood from a prophecy that one of his children would rise and dethrone him as king of the elohim-gods. To prevent this, Saturn decides to eat his children. Everyone gets eaten except for one. The one child wraps a rock in a lot of meat and tricks Saturn into eating the rock. Saturn believes he succeeded and will remain in power. The child grows up and

**KALI** - the Hindu goddess of blood, death, and destruction. She has human sacrifices performed in her name, even today. In Hindu mythology, she is a ferocious slayer and has an insatiable appetite for blood, which her servants provide for her. Here she is depicted as having born from the brow of Goddess Durga during one of her battles with the evil forces. As the legend goes, in the battle, Kali was so much involved in the killing spree that she got carried away and began destroying everything in sight.




For the construction of the [main temple](#), the Aztecs reported that they sacrificed about 84,400 prisoners in four days. Mexico City was built on these dead bodies.

## City of Sacrifice: The Aztec Empire and the Role of Violence in Civilization

At an excavation of the Great Aztec Temple in Mexico City, amid carvings of skulls and a dismembered warrior goddess, David Carrasco stood before a container filled with the decorated bones of infants and children. It was the site of a massive human sacrifice, and for Carrasco the center of fiercely provocative questions: If ritual violence against humans was a profound necessity for the Aztecs in their capital city, is it central to the construction of social order and the authority of city states? Is civilization built on violence?....>



In *City of Sacrifice*, Carrasco chronicles the fascinating story of Tenochtitlan, the Aztec capital, investigating Aztec religious practices and demonstrating that religious violence was integral to urbanization; the city itself was a temple to the gods. That Mexico City, the largest city on earth, was built on the ruins of Tenochtitlan, is a point Carrasco poignantly considers in his comparison of urban life from antiquity to modernity.

## Feasting On the Family

One of the most recent discoveries of active cannibalism practice was the Fore tribe of Papua New Guinea, which was only discovered by Westerners in the 20th century. The Fores had turned to cannibalism only recently, to compensate for the meager sources of protein on the Pacific island where they lived. Woman and children ate brains and other organs of deceased relatives for protein, while the men of the tribe

caught their own small game. This was working out OK for them until a bizarre brain disease struck the tribe and created devastating casualties and eventually led to the abandonment of the practice. Other famous alleged cannibals in anthropology include the Anasazi tribe in North America, the Aztecs in Central America, and on islands like Fiji.



**Seated around large platters, women and children consume human entrails, in this late sixteenth-century sketch by a German explorer.**





This children's rhyme implies the fun of cannibalism because it's delicious and yummy, but only if you can catch him! This becomes a game in the mind of the child. Does this make children want to run faster so they can catch him and EAT the yummy little man? How is the young impressionable mind of a child supposed to learn true love, kindness, gentleness and beauty from christian adults who force them into playing such traumatizing and ghoulish games?

This is a slick mind-control technique used to prepare the child for later in life when he/she will eat the flesh and drink the blood of their god at Communion. In the cult mys-

## Communion Gives Rise to Vampire Lore

The practice of drinking blood goes back to the first time someone bled around someone else, with notable archaeological records supporting the notion found in Mexico, China and the Middle East, as well as more recent and documented practices in Africa and the South Pacific.

Drinking blood almost always had a ritual or magical component attached to it (as opposed to cannibalism, which was often simply a dietary strategy in prehistoric times). There's just something about blood which speaks to the innermost human condition. Long before the days of DNA typing, blood was understood to be something very integral to identity.

But the blood-rites of ancient religions aren't vampirism. The historical record suggests that the concept of the vampire as recreational blood-drinker/supernatural being dates back to around the time of Yahsha the Meshiakh (Jesus Christ) who fueled the growth of such stories in very specific ways that “Christians” don't like to talk about.

After all, two particularly notable aspects from the “Bible” (manipulated versions) are present in vampire legend — the concept of rising from one's grave, and the concept of drinking human blood in order to have eternal life:

*"He who eats My flesh and drinks My blood has eternal life, and I will raise him up on the last day. For My flesh is true food, and My blood is true drink. He who eats my flesh, and drinks my blood, dwells in me, and I in him."* John 6:54-56

*(The Hebrew Messiah of Israel and Savior of the world did not make such statements! This is only a portion of the verses which scholars admit are fraudulent. Verses 51-58 will be examined extensively in Chapter 5 – Scholars Admit Forgeries.)*

Nothing ambiguous about that theme of cannibalism! The vampire as a supernatural creature lingered for some time at the fringes of civilized consciousness, but it didn't emerge as a full-fledged category of its own until much later.

There were two threads of thought that combined into the modern conception of the vampire around the time of the Middle Ages. The first was the idea of the magical/healing properties of blood. Blood was thought to contain the magical essence of life, and it was widely used in various **medical** and **occult** practices.

The second thread was the emergence of legends and rumors about the undead, soulless and unbaptized abominations who clawed their way from the grave to wreak havoc on the living. Around the same time, some of the first really gory documented tales of psychotic killers began to arise, such as the case of Sawney Bean, the leader of an incestuous cannibal tribe in Scotland, and the extremely lurid tale of **Gilles de Rais**, one of the first serial killers to be immortalized in excruciating detail, who was convicted of **Witchcraft**, summoning **Satan** and other crimes.



Later observers, such as Aleister Crowley, renown as a high priest of Satanism, defended de Rais as a victim of a politically motivated frame-up, however the list of charges and the content of the French nobleman's confession are so astonishing in their detail that it's hard to imagine it wasn't truthful. According to the Inquisition, de Rais used the blood of the hundreds of children he had allegedly killed for alchemical experiments.

The real legend of the vampire was born about the same time, over in good ole' Transylvania. Vlad Tepes, or as he is famously known, Vlad the Impaler, was a bloodthirsty prince of Transylvania in the 15th century. His father and grandfather were members of a secret society not dissimilar to the Knights Templar or the Masons.



Vlad, who also went by the name Dracula, had the bad luck to see his father ousted from the throne of Walachia when he was just 17. Hungarian nationalists backed an invasion by Dracula, who captured the throne, lost it, went into exile, then captured it again much later. Once he was firmly in place, the "fun stuff" began. Vlad's excesses are chronicled elsewhere, but he was mostly famous for impaling people. (Didn't see that coming, did you?)



Vlad wasn't actually thought to be a vampire at the time, he was seen as more of a total bastard. The connection would come later, thanks to the turgid prose of Bram Stoker. However, the same

region would play host to a more legit-i-mate vampire about 100 years later - Elizabeth Bathory.

Bathory was a Hungarian noble-woman who enjoyed **torturing** her servants and took up an interest in the Black Arts. Legend has it she was beating a servant girl for some minor infraction when the girl's blood spilled on her arm. Bathory immediately determined that her skin had improved where the blood landed, so she had the girl bled to death and bathed in her blood.

Although it seems unlikely, Bathory was convinced that this technique was making her young again, and she decided to keep it up. For about 10 years, she bathed in and drank the blood of kidnapped peasant girls on a regular basis. Eventually, her nobility was her downfall. She decided she needed a better quality of blood (possibly when her continued aging became too difficult to ignore), and started to prey on girls of noble birth. This obviously didn't sit well with the nobility, which ordered her arrested.

More than 650 girls had fallen victim to her obsession with eternal youth (she was only 50 at the time of her arrest, although that was a whole different thing in the 17th Century than it is today). Her primary servants, the ones in charge of the bleeding, were sentenced to death, but it was considered gauche to try and execute nobles, so Elizabeth herself was never put on trial. She was confined to her castle for the remainder of her life, which ended up being only four more years.

The Bathory case is perhaps the first real example of the fully formed notion of modern vampirism — the idea



that the blood of others will somehow provide eternal youth. The whole idea of the supernatural vampire didn't fully take form until Bram Stoker virtually created the concept in his novel, *Dracula*.

Stoker was an Irish author in the 19th century. He wove together a series of legends and old wives tales concerning the undead to define the parameters of the modern vampire, including the aversions to silver, garlic, sunlight and the cross, sleeping in coffins and fangs. He attached the Dracula name to his story almost as an afterthought, and he knew virtually nothing about the historical Vlad the Impaler.


By modern literary standards, *Dracula* is virtually unreadable, its florid verbiage almost drowning the awesome visuals and chilling ideas, but it was still better than most



popular fiction of that era, and it became a smash hit, sending chills down the spine of the repressed post-Victorian English and sparking a vast interest in all things vampiric. The story of Dracula grew by leaps and bounds, and vampires quickly became glorified in Western culture, boosted to warp speed by Hollywood and the introduction of the cinema. As a result of mass media, vampirism has become a literal subculture in America.


Intense and horrific scenes of massive famines are painted in the prophecies of Yahweh's inspired word. With such wretched scenes portraying cannibalism by the wicked

## *More Origins of Communion*

The sacred meal is of crucial importance in many religions, including the “advanced” ones. This developed further into the idea of eating the god to gain his strength and virtue. The Aztecs made huge loaves in the shape of the gods and these were thrown down the temple steps to be devoured by the multitude. Human sacrifice & cannibalism come to be linked again in the idea of the sacred meal, with the supreme food being used – human flesh. Communion’s pagan roots...

*“Eating the flesh of a god was of cannibalistic inception.”*

*“The pagan appeased the divine with holy bread.”*  
– wrote Tibullus

*“In Egypt, a cake was consecrated by a priest and was supposed to become the flesh of Osiris. This was then eaten and wine was taken as part of the rite.”*

*“Even in central America, among those who had never heard of Christ, Catholic missionaries were surprised to witness a religious rite which reminded them of communion...an image baked of flour, after consecration by priests, was distributed among the people who ate it... declaring it was the flesh of the deity.”*

Since heathen priests ate a portion of all sacrifices, in cases of human sacrifice, priests of Baal were required to eat human flesh. ## **Quam singulari (1910): Christian Communion**

It was on this date, August 8, 1910, that "Quam singulari," a decree of the Sacred Congregation of the Sacraments, specified the age at which children are to be admitted to first Communion in the Roman Catholic

Church.<sup>[1]</sup> The *Catholic Encyclopedia*, the authority on the subject, says that conditions for first communion include being at the "age of discretion" — defined as knowing right from wrong — and being capable of "*using ... reasoning powers.*" This last condition would seem to contradict the very idea of faith, but no matter.

In order to partake of Christian communion, the child must also "*be able to distinguish the Eucharistic from the common bread; that is, to know that what looks like bread is not bread, but contains the real, living Body and Blood of Christ.*" Leaving aside this patently ludicrous statement, what do you suppose it means that this miraculous bread, that looks like ordinary bread, "contains the ... Body and Blood of Christ"? If you eat this bread, are you eating "God"?

In ancient superstition, if you eat the flesh of your enemy, you can magically acquire his courage, his strength or even his magical powers. This "eating the god," as the Aztecs of Mexico literally called it, was described by Sir James George Frazer in *The Golden Bough*: "*by eating the body of the god, he shares in the god's attributes and powers.*"<sup>[2]</sup> When the Spaniards conquered the Aztecs, the perplexed missionaries, bent on converting the heathens, found that they were already performing a Eucharistic ritual: dough images of Huitzilopochtli were blessed by the Aztec priests, the people fasted before the communion, and the priest's words were said to cause a transubstantiation, turning the consecrated "*host*" into the flesh of the god!

Likewise for drinking the god's blood. The ritual cannibalism began with the real sacrifice of human captives of war, but evolved into a substitution of wine and bread — *or grape juice and bread for the more timid churches* — for the literal flesh and blood of the god. Similar communions were found in the Greek cult of Dionysus, the cult of Mithra and the Egyptian cult of Isis and Osiris — all of which influenced the adoption of the "Christian" Communion.<sup>[3]</sup>

As historian and ex-priest Joseph McCabe writes:

*It must not for a moment be supposed that modern educated Catholics do not literally believe this jumble of pagan superstitions and medieval verbosity. They do.... The priest dons his mystic (or Mithraic) garments, and carries his wafer to the altar. ... At the middle of the "mass" he consecrates the bread and wine ... If he does not articulate each word of the Latin formula..., if he does not say it right at the bread and wine, there will be no magic. ... He must, of course, swallow the large wafer ... without putting his teeth into "the body of Christ." He must take the "blood" without spilling a drop, for in each visible crumb of bread or drop of wine there is the whole Christ, godhead and manhood.[4]*

“Communing” with fellow Christians may encourage fellowship, but there is always a side dish of comical consequences. In his 1911 recollection of fourteen years in the Jesuit priesthood, Count Paul von Hoensbroech tells the story of an old woman who, after receiving the wafer in her mouth, contemplated that she was swallowing the genital organs of Christ himself. She spat the wafer into her prayer book, gave it to the priest, and he then had to eat it![5] ...

## The LORD MITHRA is NOT Israel's Meshiakh

*"Mithra, the Light of the World,  
is an ancient sun god born on December 25<sup>th</sup>..."*

The December 25th birthday of the sun god is a common story worldwide, dating back at least 4,000 years, as reflected in winter solstice scenes recorded in caves. Around the world beginning thousands of years ago, people have celebrated the birth of the god "Sol" (Sun) to the "Queen of Heaven," the "Celestial Virgin." The winter solstice has been celebrated in many places, from China to the Americas.



Hundreds of years before the Hebrew Meshiahk was born, ancient Greeks celebrated the birthday of Hercules and Dionysus on this date of Dec. 25th. The "Christmas" festival was celebrated at Athens and was called "the Lenaea," during which time, apparently, "the death and rebirth of the harvest infant Dionysus were similarly dramatized." This Lenaea festival is depicted in an Aurignacian cave painting in Spain, with a "young Dionysus with huge genitals," standing naked in the middle of "nine dancing women." The Romans celebrated the famed festival of "Saturnalia" at this time of the winter solstice.


The Greco-Syrian sun god Adonis was also born on December 25th, a festival spoken of by Tertullian, Jerome, and other "Fathers of the Church", who inform us that the ceremonies took place in a cave, and that the cave in which they celebrated his MYSTERIES.

Initiates of the mystery religions sought unity or "communion" with their god to achieve immortality. That

was the purpose of the pagan meal – food symbolizing the body of the god eaten to unite the worshiper with his deity. Primitive societies have always believed that cannibalism could be used to confer the qualities of the person eaten to the person doing the eating. I guess it's simply a small step to eating a person assumed to be a god incarnate to get the qualities of the god himself.

If cannibalism had died out by the time of Yahsha the Meshiakh, rites that imitated it were very common among the heathen nations. Ceres, the goddess of grain, gave her flesh to eat, and Bacchus/Dionysus, the god of wine, gave his blood to drink. The historian Durant tells us that the belief in the “transubstantiation” as practiced in the Roman church, is one of the “oldest ceremonies of primitive religion.”

Amongst the religious orders practicing this pagan rite were: Persians, Pythagoreans, Gnostics, Brahmins, Mayans and Incans. Since the days of Justin Martyr 140ce, early writers have had to explain the similarity of Communion to the pagan sacraments, such as those of Mithras. At right is the general sunburst pattern used to symbolize the host -the supposed "true body" of Christos. This design has also been adopted by the Jesuits as their symbol.



*“Mithraism had a Eucharist, but the idea of a sacred banquet is as old as the human race and existed at all ages and amongst all peoples.”*

The worship of Mithras was older by nearly two millennia than Christianity. Does it seem reasonable that the priests of Mithras copied Israelite sacrificial practice? Or is it more likely that some in the infant Messianic congregations had begun to assimilate and practice pagan doctrines due to

pressures from the official “state” religion of Rome?

Because of its evident relationship to Roman Catholicism, special attention needs to be paid to the Persian/Roman religion of Mithraism. The worship of the Indo-Persian god Mithras or Mithra dates back centuries or millennia prior to the common era. The god is found as "Mitra" in the Indian Vedic religion, which is over 3,500 years old, by conservative estimates. When the Iranians separated from their Indian brethren, Mitra became known as "Mithra" or "Mihr," as he is called in Persian. Concerning the ancient unity of the Indian and Iranian peoples, Dr. Haug states:

*"The relationship of the Avesta language to the most ancient Sanskrit, the so-called Vedic dialect, is as close as that of the different dialects of the Greek language (Aeolic, Ionic, Doric, or Attic) to each other. The languages of the sacred hymns of the Brahmans and of those of the Parsis are only the two dialects of the separate tribes of one and the same nation."*

By around 1500 BCE, Mithra worship had made it to the Near East, in the Indian kingdom of the Mitanni, who at that time occupied Assyria. Mithra worship, however, was known also by that time as far west as the Hittite kingdom, only a few hundred miles east of the Mediterranean, as is evidenced by the Hittite-Mitanni tablets found at Bogaz-Ky in what is now Turkey. As Halliday relates:

*The history of Mithraism reaches back into the earliest records of the Indo-European language. Documents which belong to the fourteenth century before Christ have been found in the Hittite capital of Boghaz Keui, in which the names of Mitra, Varuna, Indra, and the Heavenly Twins, the Nasatyas, are recorded. Further, the forms, in which the names are given, are not Iranian;*

*and it almost certainly follows that, at the time when they were written, the Iranian and Indian stocks were not yet differentiated.*

The Indian Mitra was essentially a sun god, representing the "friendly" aspect of the sun. So too was the Persian derivative Mithra, who was a "benevolent god" and the bestower of health, wealth and food. Mithra also seems to have been looked upon as a sort of Prometheus, for the gift of fire. His worship purified and freed the devotee from sin and disease. Eventually, Mithra became more militant, and he is best known as a warrior." (*Mithra - the Pagan Christ*, by Acharya S; see [www.truthbeknown.com/sunsofgod.htm](http://www.truthbeknown.com/sunsofgod.htm))

Mithraism, the soldier's cult, the official religion of Rome in Justinian's time, celebrated a ritual meal, and archaeological evidence indicates this sacrificial community meal occupied a central position in Mithraic worship. In this "divine" meal, worshipers ate the flesh of a sacrificed bull and drank its blood. When no bull was available, bread or fish were used as substitutes for the meat and wine took the place of blood. Mithraic initiates believed that, by eating the flesh and drinking the blood of the bull, they would be born again and would have eternal life.

*"He who will not eat of my body, nor drink of my blood so that he may be one with me and I with him, shall not be saved."*

## The Church Bows to Idols

*Exodus 20:4 Thou shalt not make unto thee any graven image, or any likeness of any thing that is in heaven above, or that is in the earth beneath, or that is in the water under the earth:*

*Exodus 20:5 Thou shalt not bow down thyself to them, nor serve them: ...*

Note that the commandment of Yahweh forbids making and bowing down to images and idols. Among pagans, perhaps the most common form of idolatry is sun worship, and the above prohibition would clearly exclude bowing down before images of the sun or moon (things in the heaven above). But then Yahweh gets even more explicit:

*Deut 17:2 If there be found among you, within any of thy gates which Yahweh giveth thee, man or woman, that hath wrought wickedness in the sight of Yahweh, in transgressing his covenant,*

*Deut 17:3 And hath gone and served other elohim (gods), and worshipped them, either the SUN, or moon, or any of the host of heaven, which I have not commanded; ...*

## Worshiping the Eucharist as the Sun

The Roman Catholic church teaches that in the celebration of the Eucharist the consecrated wafer and wine are miraculously changed into the actual flesh and blood of Yahsha the Meshiakh in a process called “Transubstantiation”. The centerpiece of the Catholic Mass is the Eucharistic sacrifice, a “*bloodless representation of Christ's atonement on the cross*”. The Catholic priest, or “alter Christus,” com-

mands the “Son of God” to come down from Heaven and assume the physical characteristics of a cracker and a cup of wine, that He might be CONSUMED by the priest and the faithful.



With that in mind, let's look at solar images directly associated with the Catholic Mass. Here is Pope John Paul II holding what is called a Monstrance or Ostensorium. It is used to display a round wafer of bread, called the host, which is used in what is called the Mass, Lord's Supper, Communion or Eucharistic meal. The Catholic believes this wafer of bread turns into the actual body of Christ when consecrated during the Mass. The Roman Catholic Church even admits the Monstrance to be a sunburst:

*“During the baroque period, it took on a rayed form of a sun-monstrance with a circular window surrounded by a silver or gold frame with rays.”* - The Dictionary of the Liturgy by Rev. Jovian P. Lang, OFM., published and copyrighted © 1989 by Catholic Book Publishing Co., New York, p. 436.

*“David said, Let their table be a snare, and a trap, and a stumblingblock and a recompence to them...”*

- Romans 11:9

**1413.** *By the consecration the transubstantiation of the bread and wine into the Body and Blood of Christ is brought about. Under the consecrated species of bread and wine Christ himself, living and glorious, is present in a true, real, and substantial manner: his Body and his*

*Blood, with his soul and his divinity [cf. Council of Trent: DS 1640; 1651.] --" Catechism of the Catholic Church (CCC); (C) 1994/1997 United States Catholic Conference, Inc.*

These Christian doctrines go contrary to the very Word of Yahweh, which reminds us that He does not magnify flesh!

*“...that NO flesh shall be lifted up in His presence.”*  
- 1 Corinthians 1:29





The priest (here the Pope) sometimes “lifts up” the sunburst monstrance with the Body of Jesus Christos (Mithra the Sun god) encased for the congregation to adore and venerate. Virtually any time the monstrance, a pagan sun symbol, is viewed by the congregation, they must kneel in submission.

A Catholic cannot walk past this sun symbol without acknowledging it by kneeling and or making the sign of the cross with their hands. Remember Yahweh's commandment forbidding bowing down to images? How can the Catholic justify bowing down before a sun image in veneration? This is idolatry, and not the teaching of the Savior!

Below is an artifact unearthed in the holy of holies of the pagan temple in the Canaanite city of Hatzor/Hazor, in northern Israel. It is described as follows:



At left is a pagan Canaanite cultic pillar or "matstsebah", also found in excavations of the city of Hatzor, showing hands raised in praise to the sun disk, portrayed within the crescent moon. Notice the similarity between the pagan pillar and Ratzinger's hands as seen on the cover of his book,




<On the cover of the Jan/Feb 2000 edition of **Envoy Magazine**, a Catholic publication, an elevated consecrated host of the Eucharist is unmistakably depicted as a bright yellow sun disk against the background of a cloudy blue sky!

Do you think this is what Yahsha the Messiah had in mind at the "Last Supper"? No, when He "broke the bread" He handed His disciples a *broken fragment* of leavened bread, that symbolized His broken body, but this is NOT what is

conveyed with a pressed, round, intact and unbroken wafer that has been so commonly used. The Roman church would have the world believe she is not an innovator, but, rather continues to observe the religious practices of the primitive “church”, modified only as a more clear understanding of Yahweh's righteous and “holy word”. Is that really the way?

### “HOCUS POCUS” – The Sorcery of the Church

*“When the wicked, even my enemies and my foes, came upon me to EAT UP MY FLESH, they stumbled and fell.” – Psalms 27:2*




HOC EST ENIM CORPUS MEUM ... With these Latin words of superstition (*origin of the magic formula “Hocus Pocus”*) spoken by the priest, the Catholic is taught the wafer of bread transforms into the true body of Christ

HIC EST ENIM CALIX SANGUINIS MEI ... and with these words of the priest, the Catholic is taught that the wine turns into the true blood of Christ.

Catholics are actually taught that the priest has it in his (magical) “power” to transform bread and wine into a god! This is the “hocus-pocus” witchcraft of the goddess Circe!

*(This Greek sorceress could also transform other objects, including foolish men into swine!) These alleged changes of the bread and wine into a god are not evident in any outward physical change, but are declared by the Roman Catholic Church to be a matter of (blind) “faith” to the Catholic. (With one deception after another, have you ever considered that the “Christos” of Christianity might not even be the Hebrew Messiah of Israel, but actually the mystery god Mithra? Doesn’t take a rocket scientist to figure out.)*



Above on the left you see the pagan sunburst wafer god, inscribed with IHS and the cross, is portrayed above the cup of wine. This is the door to a place where the wine and wafers are stored. Above on the right, you see a similar carving depicting angels kneeling in idolatrous adoration or worship of the wafer god and wine.

In case you think the word "worship" is an exaggeration on my part, please note this paragraph from the new Vatican Catechism of the Catholic Church:

### **1378 Worship of the Eucharist.**

*“In the liturgy of the Mass we express our faith in the real presence of Christ under the species of bread and wine by, among other ways, genuflecting or bowing deeply as a sign of adoration of the Lord. The Catholic church has always offered and still offers to the sacra-*

*ment of the Eucharist the cult of adoration, not only during Mass, but also outside of it, reserving the consecrated host with the utmost care, exposing them to the solemn veneration of the faithful, and carrying them in procession."*

At left is the reverse side of a medal commemorating the Catholic Eucharistic Congress held in Chicago in 1926 (On the front there is a bust of Pope Pius XI). Note that the round wafer host above the golden cup is portrayed as a radiant sunburst.

The Catholic Council of Trent (1545-1563) outlawed any question against the idolatry of the Mithraic feast, and declared in the canons of the Most Holy Sacrament of the Eucharist: (*here is just a portion from Catholic Canon law*)

*“1. If anyone denies that the body and blood, together with the soul and divinity, of our Lord Jesus Christ and, therefore, the whole Christ is truly, really, and substantially contained in the sacrament of the most holy Eucharist, but says that Christ is present in the Sacrament only as in a sign or figure, or by his power: let him be anathema.*

*2. If anyone says that the substance of bread and wine remains in the holy sacrament of the Eucharist together with the body and blood of our Lord Jesus Christ, and denies that wonderful and extraordinary change of the whole substance of the bread into Christ's body and the whole substance of the wine into his blood while only the species of bread and wine remain, a change which the Catholic Church has most fittingly called transubstantiation: let him be anathema.*

*3. If anyone denies that in the venerable sacrament of the Eucharist the whole Christ is contained under each species and under each and every portion of either species when it is divided up: let him be anathema.*

*4. If anyone says that after the consecration the body and blood of our Lord Jesus Christ are not present in the marvelous sacrament of the Eucharist, but are present only in the use of the sacrament while it is being received, and not before or after, and that the true body of the Lord does not remain in the consecrated hosts or particles that are kept or are left over after the Communion: let him be anathema.*

*5. If anyone says that the principle effect of the most holy Eucharist is the forgiveness of sins, or that other effects do not come from the Eucharist: let him be anathema.*

*6. If anyone says that Christ, the only-begotten Son of God, is not to be adored in the Holy Sacrament of the Eucharist with the worship of latria, including the external worship, and that the Sacrament, therefore, is not to be honored with extraordinary festive celebrations nor solemnly carried from place to place in processions according to the praiseworthy universal rite and custom of the holy Church; or that the Sacrament is not to be publicly exposed for the people's adoration, and that those who adore it are idolators: let him be anathema.”*

## The DIDACHE – Early Nazarene Worship

As the knowledge of Yahweh's Torah Law is being restored to a faithful remnant in the latter days, a critical analysis of the Greek texts, early Nazarene history and the actual Torah-based teachings of the Savior present a very different, yet a much more understandable interpretation! Other studies offered by Biblical scholars have fully addressed the Jewish rejection of human sacrifice, cannibalism and the consumption of blood, all of which practices fly in the face of the Spirit of the Law & Yahweh's clear written proscriptions. It is not my intention here to resurrect those arguments. Instead, I hope to examine how the early Nazarene's commemoration of "Yahsha's Memorial" was corrupted into today's present Catholic and Protestant tradition.

Ever since Eusebius wrote the first major history of Catholic evolution and development of the pagan church,

people have tended to idealize the primitive church as a monolithic structure with a uniform pattern of worship. Recent research has shown that was far from the true Torah-based worship of the early Nazarene movement. Converts to the Israelite Faith of the Messiah were drawn from a variety of cultures and backgrounds. Lacking a strong central governing body, the various congregations developed individual worship practices and emphasized different areas of theology guided by the Apostles. It wasn't until the 2nd Century that we begin to see the incipient development of uniformity.

From the “Gospels” of Matthew and Mark as well as Shaul's (Paul's) response to the division within the Corinthian congregation, we can get some idea of how the earliest followers of the Savior celebrated “Yahsha's Memorial”. However, most English translations reflect the added forgery of the words “eat” and “drink”. With critical help from the Book of Luke - the only “Gospel” NOT altered by Mystery Babylon - there are other written records which help us “flesh-out” and confirm a more accurate account of the Savior's Torah-based teachings.

One of them, the Didache, was rediscovered in 1873. The Didache is a manual for messianic synagogue order and Nazarene living, probably written in Syria around 60 AD. In it, we have the earliest look, outside the New Covenant writings, of Yahsha's Memorial celebration as given the night before Passover. The Didache, which recommends praying “Yahsha's Prayer” thrice daily, provides a clear picture of how early Nazarenes would gather on the Sabbath to *“break bread and give thanks”* an activity in which only baptized Torah believers were permitted to participate.

The first activity of the day involved confessing their sins and reconciling themselves with their neighbors in preparation for making themselves a pure offering to Yahweh. The actual service, which followed orthodox Jewish forms for prayer before and after meals, began with thanksgiving

over the “fruit of the vine” and bread. When offering the cup, the worship leader would give thanks for this “holy vine of David,” likely a reference to the Family of Yahweh in Meshiakh (Psalm 80:8), following up with a doxology, *“To you be majesty forever, Hallelu-Yahweh.”* There was never reference to drinking any “blood” of the Savior for salvation.

After the doxology, the worship leader would give thanks over the broken loaf, thanking Yahweh *“for the life and knowledge You have revealed through Yahsha Messiah, your son”* concluding with another doxology or hymn of praise. That was followed by a community meal though not detailed in the Didache.

Notice this early guidebook for Nazarene worship makes NO mention of eating the “*body or blood of Christ*”! The emphasis is on the gathering of the people or congregation (1 Corinthians 10:17). The Sabbath worship service as practiced by the first century Nazarenes was a “praise-celebration” of the congregation of Yahweh’s people, an event where prayers and thanksgiving, interwoven with doxologies, were offered to Yahweh.

## Mystery Babylon Seated in Rome

In the Mithran practice, the highest of seven levels of attainment for the faithful was that of “Pater” (*meaning: father – real origin of the name “Peter”*) and that the senior father was a kind of pope, or senior bishop, whose permanent residence was in the Vatican in Rome.

*“There were seven degrees of initiation into the mithraic mysteries. The consecrated one (mystes) became in succession crow (corax), occult (cryphius), soldier (miles), lion (leo), Persian (Perses), solar messenger (heliodromos), and father (pater). . . Crows, occults and soldiers formed the lower orders, a sort of catechumens;*

*lions and those admitted to the other degrees were participants of the mysteries. The fathers conducted the worship. The chief of the fathers, a sort of pope, who always lived at Rome, was called "Pater Patrum" or Pater Patratus." The members below the degree of pater called one another "brother," and social distinctions were forgotten in Mithraic unity. "*

As Catholicism gathered momentum and eventually became the Roman Empire's state religion, Mithraism became obsolete as this "new" Catholic faith transformed from it. However, there was much in the pagan practice that the new state religion adapted for its own use, arguing that they were doing these things to make it easier for them to draw converts from the cult to the bosom of the increasingly Roman church.


The Mithraic clergy's duty was to maintain the perpetual holy fire on the altar, invoke the planet of the day, offer the sacrifices for the disciples, and preside at initiations. The Mithraic priests were known as Patres Sacrorum, or Fathers of the Sacred Mysteries. Today, the Catholic parish priest is to keep always a vigil flame burning before the tabernacle or other place where the consecrated host is kept, offers sacrifices for the disciples and presides at initiations (baptisms, confirmations, holy orders).

Early in the fourth century the Emperor Constantine, who had been a Mithraic sun worshipper most of his life, claimed to have converted to "Christianity" (Catholicism) and proceeded to make it the state religion. He kept all the old traditions in order to quell the fighting and bickering between people as to which should be the state religion by attaching biblical names to the familiar rituals of paganism,

most particularly Mithraism. He also renamed the old Roman gods (idols) with the names of well-known characters from scripture, keeping the domain over which that god supposedly ruled. For example the Roman god of healing became St. Jude. It appears likely that many of the priests of the pagan religion were transformed into "Christian" priests in the new Roman Catholic Church.

Catholic church missionaries soon learned that the pagans would not abandon their customs. The customs which could not be destroyed were given a 'Christian' name and interpretation (idolatry, communion, Easter, Christmas, etc.) What Christianity couldn't eliminate, it sought to 'consecrate'.

Crackling yule-tide fires, lighted candles, dwellings adorned with evergreens, pagan feasts and giving of pagan gifts are a few of the elements that the Catholic church could not abolish. Pagan deities were supplanted by (renamed to) deceased pagan saints or enshrined in the days of the week and in the months of Rome's solar year.



The bishops of the Church apparently liked the mitres worn by Mithraic "fathers" and to this day these "princes" of the Catholic church continue to wear the mitre when they dress up for solemn occasions. These mitres represent the head of the pagan fish god Dagon – diety of the Philistines.

Again, here is a similar depiction of a pagan priest wearing a sun-fish, the head with open mouth worn as a mitre and the rest of the fish forming a cloak. These are both illustrations of Dagon, which was the god of Babylon and Philistia and is mentioned several times in scripture in

Judges 16:23, 1 Samuel 5:2-7, and 1 Chronicles 1:10. In Strong's Hebrew Dictionary, this is the definition for Dagon:

1712. **Dagown**, daw-gohn'; from H1709; the fish-god; Dagon, a Philistine deity: --Dagon.

Note the mitre on the head of this drawing of the goddess Cybele and the striking similarity to the fish head of Dagon. Cybele was worshipped in Rome and was also called the "Magna Mater", or the great queen mother goddess, which evolved into Catholic Mariology. The priesthood of Cybele was composed of castrated males, which parallels the celibate priesthood of Catholicism. The basilica of Saint Peter's, according to some, stands upon the former site of Cybele's main temple in Rome. The ruins of another temple to Cybele / Magna Mater can still be seen today in Rome on Palatine hill.



The Mithraic "pope," or Holy Father, wore a red cap and garment. His "accessories" included a ring and a shepherd's staff. I reckon the Bishop of Rome liked his style, and made the title "Holy Father" his own, as he did the label "Pontifex Maximus," along with the ring, staff, little red Skullcap and the long garment.

*"Mithra's bishops wore a mithra, or miter, as their badge of office. (Catholic) bishops also adopted miters. Mithraists commemorated the sun-god's ascension by eating a mizd, a sun-shaped bun embossed with the sword (cross) of Mithra. The hot cross bun and the mass*

*were likewise adapted to Christianity. The Roman Catholic mizd/mass wafer continues to retain its sun-shape, although its Episcopal counterpart does not.*

*All Roman Emperors from Julius Caesar to Gratian had been pontifex maximus, high priest of the Roman gods. When Theodosius refused the title as incompatible with his status as a (Catholic), the (Catholic bishop of Rome picked it up. Magi, priests of Zarathustra, wore robes that featured the sword of Mithra. Identical robes are worn by (Catholic) priests to this day.”*

Catholic priests, like Mithraic priests, became 'Father', despite Yahsha Messiah's specific proscription against the acceptance of such a title...

*“But be not ye called Rabbi: for one is your Rabbi, even Meshiakh; and all ye are brethren. And call NO MAN your father (Pope) upon the earth: for one is your Abba, which is in heaven. Neither be ye called masters: for one is your Master, even h’Meshiakh.”* -Matthew 23:8-10

The Hellenist-Gnostic spin doctors, of course, pooh-pooh the idea that the RCC continues to practice any pagan rites:

*“In its denial of the true Divinity of Christ and of every supernatural institution, modern unbelief endeavors, by means of the so-called historico-religious method, to explain the character of the Eucharist and the Eucharist sacrifice as the natural result of a spontaneous process of development in the Christian religion... In this age of Pan-Babylonism it is not at all surprising that the germinial ideas of the Christian communion should be located in Babylon, where in the Adapa myth (on the tablet*

*of Tell Amarna) mention has been found of "water of life" and "food of life" (Zimmern). Others (e.g. Brandt) fancy they have found a still more striking analogy in the "bread and water" (Patha and Mambuha) of the Mandaean religion. The view most widely held today among upholders of the historico-religious theory is that the Eucharist and the Mass originated in the practices of the Persian Mithraism (Dieterich, H. T. Holtzmann, Pfleiderer, Robertson, etc.). "In the Mandaean mass" writes Cumont ("Mysterien des Mithra", Leipzig, 1903, p.118), "the celebrant consecrated bread and water, which he mixed with perfumed Haoma-juice, and ate this food while performing the functions of divine service". Tertullian in anger ascribed this mimicking of Christian rites to the "devil" and observed in astonishment (*De prescript haeret, C. xl*)*

Did the Roman church look at pagan customs and make them her own? True history bears this out! I say, if it looks like a duck, walks like a duck and quacks like a duck, it is a duck!

*"And for this reason Yahweh will send them strong delusion, that they should believe the lie, that they all may be condemned who did not believe the truth but had pleasure in unrighteousness."*

In much of its practice, the Roman Catholic Church, and hence, the Protestant denominations and churches which follow in her blood-drinking path, prove themselves more like temples of Mithras rather than the early Torah-based

Messianic synagogues described in the Didache. The Messianic synagogues of the first century followed in the firm foundation of the word of Yahweh which said,

*“Their sorrows shall be multiplied who seek after gods/elohim: their drink offerings of blood will I not offer, nor take their names upon my lips.” – Ps. 16:4*

## *Chapter 4*

### **“Early Church Fathers” Were Gnostics**



*“Although large numbers of Jews were followers of (Yahsha Messiah), non-Jews came to predominate in the early Church. They controlled how the gospels were (re)written (and translated) after 70 ce and how the texts were interpreted. Hellenistic religion of the 1<sup>st</sup> and 2<sup>nd</sup> centuries was deeply influenced by cults called *Mysteries*, in which a worshiper would be joined to the death and resurrection of a god by ritual.”*

— “The Eucharist”, **Bible Review**, Dec. 1994, p.37.

The following quotes are from the “early Church Fathers”. They were not representatives of the Torah-teaching Savior nor the Hebrew Apostles of the first century. They were Gnostics, *ie. Hellenist agents of the Mysteries – secret knowledge from the ancient world*. With their doctrine and religious superstition rooted in the worship of pagan solar gods, they brought into the synagogues NOT the Israelite Torah Covenant, but the cannibalistic *Bloodfest of Babylon!* Doctrines of the false apostles stem from the Cult of Mithra:

*“for such are false apostles, deceitful workers, transforming themselves into the apostles of Messiah. And no marvel; for Satan himself is transformed into an angel of light. Therefore, it is no great thing if his ministers also are transformed as the ministers of righteousness – whose end will be according to their works.”*

– 2 Corinthians 11:13-15



### **THE LORD MITHRA**

These “false apostles” included:

#### **• Ignatius of Antioch**

*“I have no taste for corruptible food nor for the pleasures of this life. I desire the bread of God, which is the flesh of Jesus Christ, who was of the seed of David; and for drink I desire his blood, which is love incorruptible”* (Letter to the Romans, A.D. 110).

#### **• Justin Martyr**

*“We call this food Eucharist, and no one else is permitted to partake of it, except one who believes our teaching to be true ... For not as common bread nor common drink do we receive these; but since Jesus Christ our Savior... had both flesh and blood for our salvation, so too, as we have been taught, the food which has been made into the Eucharist ... is both the flesh and the blood of that incarnated Jesus”* (First Apology 66 [A.D. 151]).

#### **• Clement of Alexandria**

*“’Eat my flesh,’ [Jesus Christ] says, ‘and drink my blood.’ The Lord supplies us with these intimate nutrients, ...”* (The Instructor of Children 1:6:43:3 [A.D. 191]).

• **Tertullian**

*"The flesh, indeed, is washed [in baptism], in order that the soul may be cleansed . . . the flesh is shadowed with the imposition of hands [in confirmation], that the soul also may be illuminated by the Spirit; the flesh feeds [in the Eucharist] on the flesh: body and blood of Christ, that the soul likewise may be filled with God"* (The Resurrection of the Dead 8 [A.D. 210]).

• **Hippolytus**

*"And she [Wisdom] has furnished her table' [Prov. 9:2] . . . refers to his [Christ's] honored and undefiled body and blood, which day by day are administered and offered sacrificially at the spiritual divine table, as a memorial of that first and ever-memorable table of the spiritual divine supper [i.e., the Last Supper]"* (Fragment from Commentary on Proverbs [A.D. 217]).

*"The same will drink the wine of the wrath of Yahweh which is poured out without dilution into the cup of His indignation"* - Revelation 14:10

• **Origen**

*"Formerly there was baptism in an obscure way . . . now, however, in full view, there is regeneration in water and in the Holy Spirit. Formerly, in an obscure way, there was manna for food; now, however, in full view, there is the true food, the flesh of the Word of God, as he himself says: 'My flesh is true food, and my blood is true drink' [John 6:55]"* (Homilies on Numbers 7:2 [A.D. 248]).

• **Council of Nicaea I**

*"It has come to the knowledge of the holy and great synod that, in some districts and cities, the deacons administer the*

*Eucharist to the presbyters [i.e., priests], whereas neither canon nor custom permits that they who have no right to offer [the Eucharistic sacrifice] should give the Body of Christ to them that do offer [it]" (Canon 18 [A.D. 325]).*

• **Aphraahat the Persian Sage**

*"After having spoken thus [at the Last Supper], the Lord rose up from the place where he had made the Passover and had given his body as food and his blood as drink, and he went with his disciples to the place where he was to be arrested. But he ate of his own body and drank of his own blood, while he was pondering on the dead. With his own hands the Lord presented his own body to be eaten, and before he was crucified he gave his blood as drink" (Treatises 12:6, [340]).*



• **Cyril of Jerusalem**

*"The bread and the wine of the Eucharist before the holy invocation of the adorable Trinity were simple bread and wine, but the invocation having been made, the bread becomes the body of Christ and the wine the blood of Christ" (Catechetical Lectures 19:7 [A.D. 350]).*

*"Do not, therefore, regard the bread and wine as simply that; for they are, according to the Master's declaration, the body and blood of Christ. Even though the senses suggest to you the other, let faith make you firm. Do not judge in this matter by taste, but be fully assured by the faith, not doubting that you have been deemed worthy of the body and blood of Christ. . . . [Since you are] fully convinced that the apparent bread is not bread, even though it is sensible to the taste, but the body of Christ, and that the apparent wine is not wine, even though the taste would have it so, . . . partake of that bread as something spiritual, and put a cheerful face on your soul" (ibid., 22:6, 9).*

• **Ambrose of Milan**

*"Perhaps you may be saying, 'I see something else; how can you assure me that I am receiving the body of Christ?' It but remains for us to prove it. And how many are the examples we might use! . . . Christ is in that sacrament, because it is the body of Christ" (The Mysteries 9:50, 58 [A.D. 390]).*

*"But there were also false prophets among the people then, just as there will be false teachers among you, who will secretly bring in damnable heresies, even denying the Redeemer who bought them – and bringing swift destruction upon themselves. And many will follow their destructive ways, and because of them, the way of truth will be defamed." – 2 Kepha 2:1*

**"Early Church Fathers" Not Reliable**

We receive many letters from Catholics that feel the writings of the early "church fathers" are reliable sources for what should be practiced by Yahweh's people. Of course, my response is always the same, go back to the word of Yahweh and read what Yahsha and His Apostles said - even considering possible mistranslations by those so-called "Church Fathers". This is the "*more sure foundation*" that Kepha told us we could trust! Nonetheless, they argue vehemently for their cause. For a Catholic, their "sacred tradition" is equal to the Covenant Word of Yahweh.

*The Catechism of the Catholic Church*, #82, reveals:

*"...Both Scripture and Tradition must be accepted and honored with equal sentiments of devotion and reverence." (Pagan "Tradition" – emphasis mine)*

The *Question Box Column*, Brooklyn Tablet, Nov. 8, 1958, even went so far as to say:

*“Tradition as a source of Faith would suffice **without** Scripture”.* (remember – “Tradition” here is Mithra!)

For tradition to be EQUAL to Scripture, it would be necessary for it to live up to the standards that the Scripture dictates for itself. If tradition fails to live up to those standards, then it cannot claim equality. Let's take a look at what the Scripture says about itself. The Hebrew word of Yahweh is “pure... perfect... inerrant... infallible... sure... and truthful.” (Psalm 19:7, Isaiah 8:20; Matthew 19:17).

Let's examine Rome's tradition and see if it is indeed pure, truthful and sure.

The most influential book ever written by a Catholic, the Code of Canon Law known as the *Decretum*, was written in the mid-1100's by a Benedictine monk named Gratian. He quoted from popes 324 times, but only eleven of those are genuine. He not only depended on 3rd century forgeries and his own faulty conclusions from them, but he also used the 9th century forgeries known as the Isidorian and Cyril Decretals, which contained hundreds of supposed quotes from early church fathers and popes, none of which were legitimate. Now, we go to Thomas Aquinas in the 13th century. He writes his *Summa Theologica*, the second-most renown work by a Catholic. He bases all his conclusions on the work of Gratian. This doesn't include all the other authors, who throughout the centuries, quoted from both these men's works. All of them based on lies.

There is a book by a Catholic apologist, Scott Hahn, entitled, *The Lamb's Supper*. Mr. Hahn claims that one cannot understand the book of Revelation unless they understand the Catholic Mass. According to Scott, one who partakes in the Catholic Mass has entered “heaven on earth”. As I sat reading, I noticed that Scott was quoting from known forged works. I had to wonder if he was aware of these facts and didn't care or if he had truly been deceived himself. I

prefer to believe the latter. Nonetheless, I feel compelled to alert anyone who reads Mr. Hahn's material to beware of his sources. Let me give you a few examples. On page 37, we read:

*“From the beginning of the third century onward, the papyrus trail shows a greater concern with preserving the precise words of the liturgies attributed to the Apostles. In the early 300's A.D., in northern Syria, surfaces another compilation of the received tradition: the Didascalia Apostolorum “Teaching of the Apostles”. The Didascalia includes pages of texts of prayers as well as detailed instructions for liturgical roles and etiquette of bishops, priests, deacons, women, children, young adults, widows, orphans and travelers.”*

Had Scott Hahn read the *Catholic Encyclopedia*, IV, page 782, he would have known that the *Didascalia* is a “*treatise which PRETENDS to have been written by the Apostles at the time of the Council of Jerusalem, but is really a composition of the third century*”. This forgery was also “*incorporated into the Apostolic Constitutions in the fifth century*” (781). If someone pretends something is written by the Hebrew Apostles, and it is NOT, then they are liars. Satan is “the father of lies”, not Yahweh (Yahchanan/John 8:44).

*“Ye are of your father the devil, and the lusts of your father ye will do. He was a murderer from the beginning, and abode not in the truth, because there is no truth in him. When he speaketh a lie, he speaketh of his own: for he is a liar, and the father of it.”* - Yahchanan 8:44

The persons responsible for these forgeries are liars! Are they going to teach us about Yahweh using the very thing they lied about? 1 Yahchanan/John 2:27 teaches otherwise.

*“But the anointing which ye have received of him abideth in you, and ye need not that any man teach you: but as the same anointing teacheth you of all things, and is truth, and is no lie, and even as it hath taught you, ye shall abide in him.” – 1 Yahchanan/John 2:27*

My next question would have to be: “Why is Rome depending on forgeries and lies rather than on the word of Yahweh?” *Because she is the Whore of Babylon appointed by Satan the Devil to deceive the whole world!* –Revelation 12:9 Does it matter to the Catholic that the writings they so depend on are forgeries? If it matters, then why do they continue to use them? Why don’t they admit that the only foundation for the Roman Catholic ecclesiastical government are the forged Clementines? (20 books supposedly quoting the early “popes”) Because it is their desire to dupe the whole world into accepting their blasphemous priest-craft and sins wherein they rule over men’s souls.

So, what could these Roman forgeries known as “*the Clementines*” claim? In the *Catholic Encyclopedia*, Volume IV, page 41, we read:

*“A letter from Clement to James forms an epilogue to H. In it Clement relates how Pater (not Peter/Kepha – the Jewish Apostle of the Meshiakh! – emphasis mine) before his death gave his last instructions and set Clement in his own chair as his successor in the See of Rome...The writer knows a complete system of ecclesiastical organization. Pater sets a bishop over each city, with priests and deacons under him; the office of bishop is well defined...”*

Catholic authorities NOW ADMIT that no such an arrangement prevailed in Apostolic times, and for a few hundred years afterwards. Speaking of *the Clementines*, the

*Catholic Encyclopedia* (pg.67) says that “*they were very popular in the Middle Ages.*” Though they are now admitted, since the sixteenth century, to have been a huge forgery, the “infallible Church” and their “infallible popes” used them continually and still do! Like most of the forgeries, they were re-forged, occasionally, to bring them up to date. That’s why the *Catholic Encyclopedia* speaks of “*the earliest form of the Clementines*”, (Vol. IV, 42) and again, “*the date of the original is therefore fixed as after Nicaea, 325, probably c. 330; ...anywhere in the second half of the fourth century*” (Vol. IV, 44). This reveals the continual amending and the use that was being made of the forgeries. Rome even admits this on page 41 of the *Catholic Encyclopedia*, Volume IV:

“*To show how it is necessary for them to be constantly re-forging these forgeries we learn that the earlier editions of these works made James and not Peter head of the Church.*” (Their own words condemn them!)

The Scripture is clear on who the head of the congregation is: Yahsha h’Meshiakh -Chief Cornerstone of Bayit Yahweh.

“*And hath put all things under his feet, and gave him to be the head over all things to the Family of Yahweh.*”  
-Ephesians 1:22 (Hebrew “Bayit” means: house/family)

“*But speaking the truth in love, may grow up into him in all things, who is the head, even the Meshiakh.*”  
--Ephesians 4:15; (Also see: Colossians 1:18; 2:10,19)

The Scriptures teaches us that we are “*not to think of men above that which is written*”. (1Cor.4:6) The office of “Pope” cannot be found in the Scriptures for any Apostle.

Kepha (Peter) would have been appalled that Catholic “Christianity” took the title “*Pontifex Maximus*” and

applied it to him. That was the title of the pagan high priest of Rome during his lifetime. The Apostle Kepha never claimed to be “head” of the House of Yahweh, nor the “*Bishop of Rome*”. The early Messianic synagogue knew of no ecclesiastical system of government as evident from scripture, yet Rome will use forgeries to bring men under bondage to their Mithraic priesthood. It has always been her method! Just as the Roman Catholic Church used *The Donation of Constantine* – another known forgery - to take possession of the Roman Empire.

It’s evident that we can’t trust the writings of the so-called “Early Church Fathers” of Rome as a sure foundation. They have lies mixed-in with the Truth, and 1 Yahchanan/ John 2:21 says “*no lie is of the truth*”. The standards that the Scriptures dictates for itself depends on its being “pure, perfect, sure and true” based on the Torah Law & Prophets.

*“To the Torah Law and to the Prophets, if they speak not according to this word, it is because there is no light in them.”* – Isaiah 8:20

If anything claims equality, then it must also be “pure perfect, sure and truth”. Rome’s tradition and her so-called “Church Father’s” teachings DO NOT line up! They readily admit this themselves! From the *Catholic Encyclopedia*, Vol. XV, page 10, we read:

*“When the Church studies the ancient monuments of her faith she casts over the past the reflection of her living and present thought and by some sympathy of the truth, today with that of yesterday she succeeds in recognizing through THE OBSCURITIES AND INACCURACIES of ancient formulas and portion of traditional truth, even though they are MIXED WITH ERROR...”*

This next quote makes me seriously wonder if Rome thought no one would ever read their encyclopedia and realize how ridiculous they sound:

*“Even though it must be admitted that the popes benefited by the forgeries, their good faith is beyond question.”* (Ibid., V., 788)

For 1500 years, Augustine was considered one of the greatest teachers of the Catholic Church. His influence was so great that about 200 years after his death at least three works were forged in his name. These works justified practices that were unknown in Augustine’s time. It was these forgeries that Thomas Aquinas quoted from (along with the forgeries of Gratian). Since Thomas Aquinas is considered the greatest teacher of Catholic history, these forgeries are still exerting their influence. These works are named *De Condition Cordis* (*Summa*, Part III, Fourth Number, 119), *De Penitentia* (*Summa*, Part III, Third number, 57) and *Hypognosticon* (*Summa*, Part III, Third Number, 77).

*“There is a conspiracy of her prophets in her midst ...they have devoured souls...Her priests have violated My Torah Law...”* – Ezekiel 22:25-26a

The above evidence and admissions show once again the futility and vanity of man’s deceitful religious dogma and superstitions. The eye-witnesses of the Savior – the Apostles and disciples - warned thousands of years ago against the false doctrines and outright forgeries made by these Gnostic “false apostles”.


Yet, behold the absolute perfection found in Yahweh’s inspired and unchanging Word: the center of all Scripture is Psalms 118:8. The shortest chapter is Psalms 117 and the longest chapter in Scripture is Psalms 119. There are

594 chapters before Psalms 118 and 594 chapters after it. These numbers add up to 1188. Psalms 118:8, the very center of Yahweh's perfect word sums up this chapter:

*“It is better to trust in Yahweh  
than to put confidence in man.”*

Why would man want to corrupt that which is perfect? Yahweh's perfect word instructs mankind to never drink blood, but the Gnostics of Mystery Babylon would not obey! They are responsible for the corruptions of Yahweh's inspired words. By “adding to” the words of the Hebrew Savior, the Gnostics have spread their ritual sin and worship of Mithra to all the world through the mass publication of the altered Greek to English translations! Will you follow the loving and righteous Covenant word of Yahweh, or follow in the pagan filth and abominations of Mystery Babylon? Two Witness Ministries exposes the fraud! Yahweh bless you for your desire to know these facts and for your humble obedience to Him and His Anointed One.

## *Chapter 5*



## **Scholars Admit Forgeries**

*“...Behold, the lying/forgorous pen of the scribes have falsified them, and written them wrong.”*

– Yeremiah 8:8

Bible scholars are well aware of Gnostic influence upon the interpreting and translation of the Apostolic writings. These became the Catholic Church's forgeries which were prophesied by the prophets to deceive trusting yet gullible Christians into practicing the pagan rites and worship of Lord Mithra. This is why the Savior labeled pagan Christianity as “Mystery Babylon the Great.”

Astute scholars, skeptics, honest laymen have always wondered about this Communion contradiction...*How could the Torah-teaching Hebrew Messiah institute a gruesome ritual of cannibalism that goes against the Torah Law of*

*Yahweh and civilized social customs?* This is why scholars have been *RE*-examining the questionable passages of Yahchanan 6:51-58 and accounts of the “Last Supper” due to their unabashed theme of cannibalism. Changing the codified Word violates Yahweh’s instruction from His Torah Law:

*“You shall not add to the words which I instruct you, nor shall you take anything from it, so that you can keep the instructions of Yahweh which I decree to you.”*

– Deuteronomy 4:2 and ch.12:32

Scholars are coming out and admitting to the numerous revisions and alterations made by these “Early Church Fathers”:

*“What (Yahsha) was doing at the Last Supper has not been understood for the better part of 2,000 years. The reason for the misunderstanding is that (Yahsha) , a Jewish teacher... has been treated as if he were the deity in a Hellenistic-Greek cult. A generation after (Yahsha’s) death, when the Gospels were written, the Romans had destroyed the Jerusalem Temple (in 70 ce.); the most influential centers of (Catholicism) were cities of the Mediterranean world such as Alexandria, Antioch, Corinth, Damascus, Ephesus and Rome. Although large numbers of Jews were followers of (Yahsha Messiah), non-Jews came to predominate in the early Church. They controlled how the gospels were (re)written (and translated) after 70 ce and how the texts were interpreted. Hellenistic religion of the 1<sup>st</sup> and 2<sup>nd</sup> centuries was deeply influenced by cults called Mysteries, in which a worshiper would be joined to the death and resurrection of a god by ritual.” (ie. Communion – emphasis mine)*

- “*The Eucharist – Exploring Its Origins*” article by Bruce Chilton, **Bible Review**, December 1994, p.37.

The “early Church Fathers” were those “*non-Jews*” Gnostics of the Mystery Cults and the very “false prophets” which the Apostles warned their newly-converting gentile congregations. Religious cannibalism had been an ancient ritual rooted in the worship of Mithra and Dionysus, and these “Church Fathers” were obviously DEVOUT cult members. With the “miraculous” growth in the first century of Nazarene synagogues, the god of this world had to devise an effective resistance to stop it, or else, *change its course!* Satan orchestrated his Gnostic agents of Mystery Babylon to conduct an effective counterstrike against the fastest growing movement of pure righteousness the world has ever seen.

After the Temple’s destruction by Rome in 70ce and the deaths of the original Apostles - having been martyred by Rome (Read: **Foxes’ Book of Martyrs**) the true Nazarene worshipers of Yahweh came under increasing attacks. In order to regain power and control over a people’s religion, Mystery Babylon – Rome knew it had to seize control of the New Covenant writings. This was accomplished by hijacking the letters, texts, manuscripts and written correspondence of the Apostles. Their original Hebrew letters and teachings were then systematically retranslated by the Early Church Fathers into the Greek tongue, then manipulated, edited, redacted and retransmitted back to all the gentile congregations that were spreading like wildfire all over the Roman empire.

The Apostle Shaul (Paul), a Hebrew-speaking Jewish Pharisee, was hand-picked from heaven by the Savior to preach Israel’s Covenant of eternal life to Gentiles. Highly trained in the Torah and Prophets – Shaul upheld this true foundation of righteousness taught by the Meshiakh, saying,

*“for not the hearers of the Torah Law will be justified,  
but the DOERS of the Torah Law will be justified”*  
– Romans 2:13

Fully aware of Satan's agents and their deceit, he was forced to warn his fledgling congregations that forgeries were being circulated in his name without his permission. Shaul labeled these early Church Fathers as “false apostles”.

*“But what I do, I will also continue to do, in order that I may cut off the opportunity of those who want to be regarded as equal with us, in what they boast about. For such are false apostles, deceitful workers, transforming themselves into the apostles of Meshiakh. And no marvel for Satan himself is transformed into an angel of light.”*

– 2 Corinthians 11:12-14

*“That you not be soon shaken in mind, nor be troubled, neither by spirit, or by word, nor by letter... AS IF from us...”* – 2 Thessalonians 2:2

The Apostle Shaul had to respond to these false doctrines which were being circulated in “his name”! Later in life, as he was losing his eyesight, he had to write his letters in LARGE SCRIPT and made this point to the Galatian congregation, so that any forged letters would be obvious.

*“Ye see how LARGE a LETTER I have written...”*  
– Galatians 6:11

Numerous false doctrines and forgeries were making their way to Shaul's congregations before his death, including the cannibalism ritual from these Fathers of Mithra.

The Savior even identified these “Church Fathers” in his heavenly warning to the Ephesus congregation as seen in Revelation 2:2, recorded by the exiled Apostle Yahchanan,

*“I know your works and your labor and your patience, and how you cannot bear those who are evil; and you*

*have tried those who say they are apostles, and are NOT, and have found them liars.”*

The Apostle Shaul had to address the heresy of religious cannibalism which was causing “division” in the Corinthian congregation (1 Corinthians 11:17-19). This very revealing discourse will be carefully examined in Chapter 9.

To spread the ancient ritual of “eating the flesh” and “drinking the blood” of the god (Mithra/Dionysus/Osiris,etc) this theme was systematically inserted into various passages of the later Greek translations. Numerous scholars are now on record as concluding that the questionable sermon of religious cannibalism as found in Yahchanan/John 6:51-58 (and *NOWHERE ELSE*) is indeed prime Gnostic forgery!

By intercepting and manipulating the Greek translations, inserting (adding) a few words here and there, the “damnable heresy” of Mithraic cannibalism became the religious doctrine of the newly formed “Church”. This is why the Roman Church defends the Greek translations over accepting the factual evidence of Hebrew originals. The following material is powerful evidence against the Mithraic sermon and Gnostic forgery of Yahchanan/John 6:51-58.

## **The Anchor Bible**

From **The Anchor Bible**, under “The Gospel According to John, Introduction, B. Sacramentalism”, p. CXI,

*“Perhaps on no other point of Johannine thought is there such sharp division among scholars as there is on the question of Sacramentalism (Eucharist/Communion)... there is a group who see NO references to the sacraments in John. For some, the original gospel was anti-sacramental! In general, they base their case on the lack of overt references to the Eucharist in John*

*...John narrates neither the eucharist action of Jesus (Yahsha) at the Last Supper...John has created a theological atmosphere that would (make unnecessary) material intermediaries like the sacraments. The emphasis in John is on “word” NOT on sacraments. Scholars such as Bultmann and Bornkamm call attention to the ‘Ecclesiastical Redactor’ due to differences in style, breaks and inconsistencies in sequence, repetition in discourse, and passages not belonging to their context” Theories view John 6 as having undergone several editions and redactions...For instance, one German scholar arrived at six combinations of these.”*

**The Anchor Bible** commentary declares,

*“The problems in John are obvious, and it is possible that various editings caused these problems.”*

From pp. XXIV-XXXIV of this same Introduction, we find the following questions, statements and conclusions:

***“II. The Unity and Composition of the Fourth Gospel***

**A. The Problem** – *Is the Fourth Gospel as it now stands the work of one man?..there are features in the Gospel that offer difficulty for any theory of unified authorship... We find these major difficulties,*

- 1. there are differences in Greek style*
- 2. there are breaks and inconsistencies in sequence, ie geographical and chronological*
- 3. there are repetition in the discourses, as well as passages that clearly do not belong to their context*

**B. Possible Solutions**

- 1. theories of accidental displacements*
  - a. assumed this took place after the death of John*
- 2. theories of multiple sources*

*a. this theory views the Gospel as having undergone several editions and redactions...For instance, in the early part of this century one German scholar arrived at six combinations of sources and redactions.*

*3. theories of multiple editions*

*a. The pattern common to these theories is that one basic body of Gospel material has been edited several times to give us the present form of John.”*

On page 284, we see the General Comments for v.51-58,

*“in this section, the Eucharistic theme which was only secondary in v.35-50 comes to the fore and becomes the exclusive theme. No longer are we told that eternal life is the result of believing in (Yahsha); it comes from feeding on his flesh and drinking his blood (54)...If we grant that the primary meaning of the “bread of life” changes in vss.51-58 from the meaning seen in vss.35-50, do the two parts of the discourse really belong together?...Is vss.51-58 an extraneous block of material?”*

Continuing, this same source on page 259 admits,

*“These observations do not rule out the possibility that vss.51-58 were ADDED at a LATE stage of the editing of chapter 6...”*

then, page 287 concludes,

*“...vss.51-58 WERE ADDED to vss.35-50 at a fairly LATE STAGE in the editing of the Fourth Gospel probably in the final redaction (editing).”*

Powerful admissions! Numerous scholars and Bible commentaries are now in agreement that this is HOW this pagan ritual to the mystery gods Mithra/Dionysus/Osiris – *now known as Communion* – came to be found within the “New Testament” Greek text of Yahchanan/John chapter 6. This was the crafty work of the Gnostics of Mystery Babylon – the “Early Church Fathers” – forgeries by “false apostles”!

With these revelations and much more to come,  
***Communion's foundation is cracking!***



## Chapter 6

**Messiah Taught the Torah!**

### **“It is Written!...”**

*“O FOOLS and slow of heart to believe all that the Prophets have spoken...These are the words which I spoke to you while I was still with you; All things must be fulfilled which are WRITTEN in the Torah Law and the Prophets and in the Psalms concerning Me.”*

— Luke 24:25,44

Seeing then that Rome admits her tradition is not pure, sure, perfect or even truthful, we would do well to take heed to the pure, perfect, truthful, and “more sure word” of Yahweh. For disbelief, the Savior calls Christians “fools”.

Scripture warns us about the foolishness of trusting in man and his religious traditions (Yeremyah/Jeremiah 17:5). Ancient Israel’s “fathers” often led Yahweh’s people into idolatry disregarding the warning of Yahweh’s Prophets. Likewise, so have the Church Fathers of Roman Catholicism and the Reformers of Protestantism led their sheep along the dry riverbeds and grassless wilderness of Baal worship.

## The Faith of the Savior

Yahsha the Meshiakh followed the perfect pattern of righteousness and taught that true life was gained by living...

*“...it is WRITTEN, man does not live by bread alone, but by every word that proceeds out of the mouth of Yahweh”*

- Matthew 4:4 (quoting the Torah - Deuteronomy 8:3)

After His baptism, Yahsha the Meshiakh was then tempted of the Adversary. He quickly replied with the words, *“It is written!”* This is the example which the King Yahsha the Meshiakh set before us. Yahsha did not combat lies with the *“traditions of the fathers.”* He scolded the Jewish leadership that even their traditions were making the Word of Yahweh of none effect. Mark 7:7-8, and then verse 13 reads,

*“But in vain do they worship Me, teaching as doctrine the commandments of men. For laying aside the commandment of Yahweh, you hold the tradition of men! ...Making the Torah Law of Yahweh of **no effect** through your traditions which you have handed down!”*

The leaders of Israel repeatedly caused their people to go into apostasy. Christian leaders today teach these same errors & traditions of their fathers! Yeremyah 9:13-15 says,

*“And Yahweh saith, Because they have forsaken my law which I set before them, and have not obeyed my voice, neither walked therein; But have walked after the imagination of their own heart, and after Baalim (lords, gods, elohim), WHICH THEIR FATHERS TAUGHT THEM: Therefore thus saith Yahweh of hosts, the Mighty One of Israel; Behold, I will feed them, even this people, with wormwood, and give them water of gall to DRINK.”*

Notice how Yahweh says that it was the fathers that taught them to commit idolatry. Israel's fathers taught them to serve Ashteroth, the “queen of heaven”. Rome has done the same thing, they just call their “Queen of heaven” by another name. One of the fathers of Israel, Jeroboam, the king of Israel, set up golden calves in Bethel and Dan and had the people go up to worship there instead of Jerusalem. Israel fell into great apostasy by obeying their fathers who led them away from Yahweh's inspired, loving and saving instructions. Yahweh then sent His prophet to Jeroboam.

*“And, behold, there came a man of Yahweh out of Yah-dah by the word of Yahweh unto Bethel: and Jeroboam stood by the altar to burn incense. And he cried against the altar in the word of Yahweh, and said, O altar, altar, thus saith Yahweh: Behold, a child shall be born unto the house of David, Yoshiyah by name; and upon thee shall he offer the priests of the high places that burn incense upon thee, and men's bones shall be burnt upon thee.”*

- 1 Kings 13:1-3

Yahweh named Yoshiyah (KJV-“Josiah”) long before he came. Yahweh wants men to know that He is in control. He wants men to know that His word stands and you can trust it. 2 Kings 22 tells us that Yoshiyah was eight years old when he began to reign, and the Scripture says that he did that which was right in the sight of Yahweh and walked in the way of David. In the eighteenth year of Yoshiyah's reign, it was on his heart to repair the breaches in the Temple of Yahweh, but it was the heart of Yahweh to repair the hearts of His people. Yahweh knows that there is only one way to do this. The people needed to hear His perfect word.

*“And Hilkiah the high priest said unto Shaphan the scribe, I have found the book of the Torah in the house of*

*Yahweh. And Hilkiah gave the book to Shaphan, and he read it. And Shaphan the scribe came to the king, and brought the king word again, and said, Thy servants have gathered the money that was found in the house, and have delivered it into the hand of them that do the work, that have the oversight of the house of Yahweh. And Shaphan the scribe showed the king, saying, Hilkyah the priest hath delivered me a book. And Shaphan read it before the king. And it came to pass, when the king had heard the words of the book of the Torah, that he rent his clothes.” - 2 Kings 22:8-11*

Notice the heart of Yoshiyah. He heard the words of the book of the Torah and rent his clothes. He didn’t hear the words and question if Yahweh really said that or not! He knew they were the words of the living Creator. They pierced him to the heart. Verse 13, Yoshiyah said:

*“Go ye, inquire of Yahweh for me, and for the people, and for all Yahdah, concerning the words of this book that is found: for great is the wrath of Yahweh that is kindled against us, BECAUSE OUR FATHERS HAVE NOT HEARKENED UNTO THE WORDS OF THIS BOOK, TO DO ACCORDING UNTO ALL THAT WHICH IS WRITTEN concerning us.”*

Notice it was Israel’s forefathers that led their children into sin. They didn’t hearken unto...

*“...THAT WHICH IS WRITTEN”*

Let’s continue. They went to Huldah the prophetess, who dwelt in Jerusalem and they spoke with her.

Starting in verse 15,

*“And she said unto them, Thus saith Yahweh Mighty One of Israel, Tell the man that sent you to me, Thus saith Yahweh, Behold, I will bring evil upon this place, and upon the inhabitants thereof, even all the words of the book which the king of Yahdah hath read: Because they have forsaken me, and have burned incense unto the elohim, that they might provoke me to anger with all the works of their hands; therefore my wrath shall be kindled against this place, and shall not be quenched. But to the king of Yahdah which sent you to enquire of Yahweh, thus shall ye say to him, Thus saith Yahweh Mighty One of Israel, As touching the words which thou hast heard; Because thine heart was tender, and thou hast humbled thyself before Yahweh, when thou hearest what I spake against this place, and against the inhabitants thereof, that they should become a desolation and a curse, and hast rent thy clothes, and wept before me; I also have heard thee, saith Yahweh. Behold therefore, I will gather thee unto thy fathers, and thou shalt be gathered into thy grave in peace; and thine eyes shall not see all the evil which I will bring upon this place. And they brought the king word again.”*

When Yoshiyah heard the word of Yahweh and repented, Yahweh heard him. Do you know what Yoshiyah did?..this man who's heart was tender when he heard the word of Yahweh?

*“And the king sent, and they gathered unto him all the elders of Yahdah and of Yerusalem. And the king went up into the house of Yahweh, and all the men of Yahdah and all the inhabitants of Yerusalem with him, and the priests, and the prophets, and all the people, both small and great: and he read in their ears all the words of the book of the covenant which was found in the house of*

*Yahweh. And the king stood by a pillar, and made a covenant before Yahweh, to walk after Yahweh, and to keep His commandments and His judgments and His statutes with all their heart and all their soul, to perform the words of this covenant that were written in this book. & all the people stood to the covenant.”* -2 Kings 23:1-3

Yoshyah went on to destroy and tear down the erect steeples in Israel, and he did mighty works simply because he believed Yahweh’s Word. Don’t be deceived by so called “church fathers” and all the forgeries of Rome. Yahweh did not promise to preserve the words of men, He promised to preserve His Words. And even though Israel fell into apostasy many times, not one promise of Yahweh ever failed.

## **The Savior Follows the Torah**

*“It is easier for heaven and earth to pass away, than for one yode or letter of the Torah Law to fail.”*  
– Luke 16:17

Yahsha knew that ***nothing*** in the Law and Prophets could be changed, and why He was so confident in quoting the Torah Law during His trial of temptations offered by the Adversary of Yahweh – h’Shattan - the Devil in Matthew 4,

*“Then Yahsha was led up by the spirit of Yahweh into the wilderness, to be tempted by Satan the devil. And when He had fasted forty days and forty nights, after-ward He was hungry. So when the Tempter came to Him, he said, If you are the Son of Yahweh, command that these stones be turned to bread. But Yahsha answered and said, IT IS WRITTEN: Man does not live by bread alone, but by the every word that proceeds out of the mouth of Yahweh...”*  
vss.1-4 ( See the Torah - Deuteronomy 8:3.)

In each of the three temptations, Yahsha defeated the devil by introducing the Torah Law with “*IT IS WRITTEN!*”

**Matthew 4:7**, “*Yahsha replied to him, IT IS WRITTEN: You must not tempt Yahweh.*” (Torah – Deuteronomy 6:16)

**Matthew 4:10**, “*Then Yahsha said to him, Satan get away! For IT IS WRITTEN: Yahweh you must reverence, and Him only you must serve!*” (Torah – Deuteronomy 6:13)

“*To the Law and the Prophets, if they speak not according to this word, it is because there is no light in them.*”

– Y’shayah/Isayah 8:20

The Hebrew Meshiakh was called, “*the light of the world*” by His own second cousin – the Levitical priest – Yahchanan the Immerser (known as “John the Baptist” in the English KJV. See Yahchanan/ John 1:7-10) This was because the Meshiakh would come teaching the Torah Law which was also referred to as “*the light*” (see Psalms 119:105, 130).

“*For the commandments are a lamp, the Torah is light...*”

- Proverbs 6:23

Before the children of Israel crossed over the Yordan River to enter the Promised Land, Moshe prophesied that the Meshiakh would teach the Torah Law in Yahweh’s Name,

“*I will raise up for them a Prophet like you from among their brothers, and I will put My words in His mouth, and He will tell them EVERYTHING I command Him. Who-ever will not listen to My words, which He speaks IN MY NAME, I will judge him for it.*” – Deuteronomy 18:18-19

Yahsha was prophesied to speak the Torah of Yahweh.

This is what made Him “*the light of the world*”. He said,

*“Then Yahsha spoke again to them, saying, I am the light of the world. He who follows Me will not walk in darkness, but will have the light of life.”*

– Yahchanan/John 8:12

Yahsha was the light of the world because He walked in the Torah Law of Yahweh founded upon the same covenant made to Adam, Abraham, and the children of Israel at Mt. Sinai after their miraculous deliverance from Egyptian bondage. Yahweh offers this same covenant to you and me,

*“For this covenant is the SAME covenant that I will renew with the house of Israel: After those days, says Yahweh; I will put my Torah in their inward parts, and write it in theirs hearts; and I will be their Abba, and they will be My people.”* – Hebrews 8:10

There is no other foundation for the Kingdom of Yahweh, except the Torah Laws of Yahweh. This Covenant contains all the promises of blessings for obedience and the curses for disobedience. (Deut.28; Lev.26) This is why the Meshiakh preached repentance – so all nations could receive blessings!

*“Yahsha began to preach and to say, Repent, for the Kingdom of Yahweh is at hand!”* – Matthew 4:17

Even at the age of 12, Yahsha the Messiah was so educated and familiar with all the Torah and Prophets that He confounded the Jewish teachers at the Temple with His wisdom! (Luke 2:46-47) His knowledge of and obedience to the Torah and the Prophets is what qualified Him to be the unblemished Lamb of Yahweh to bear the transgressions of *repentant* men. The Baptist knew He was Yahweh’s chosen,

*“...Behold the Lamb of Yahweh who takes away the sin of the world.”* – Yahchanan/John 1:29

The Lamb of Yahweh will enforce Yahweh’s Torah as the Supreme Law to govern Earth after His return and final judgment upon the Church of Babylon and the Beast of the United (gentile) Nations (Isayah 2:2-4; Micah 4:1; Revelation 17:12-14). Those who do not humbly repent and bow to Yahweh’s beloved Son the “King of kings” - Yahsha the Meshiakh - must die the Second Death (the death of the spirit) never to taste the consciousness of life ever again. (See Luke 3:9; Philippians 2:8-10; Revelation 20:15)

*“Yahsha proclaimed: I am the way, the truth and the life. No one comes to Abba Yahweh, except through Me.”*  
– Yahchanan/John 14: 6

One such transgression of the Torah is eating the sacrifices to the elohim/gods of the nations. This includes “eating” the flesh and blood sacrifice to Mithra – the body of the god! Communion was a pagan ritual that even ancient Israel was warned NOT to engage in.

*“Be careful to make no treaty with those who live in the land; for when they prostitute themselves to their elohim and sacrifice to them, they will invite you, and you will eat and drink their sacrifices.”* –Exodus 34:15

Religious cannibalism was a practice of all the gentile nations, and Yahweh’s Torah Law set Israel apart as a righteous nation. Mosheh recorded Yahweh’s instructions, which the Savior then fulfilled,

*“I will raise up a Prophet like you from among their brothers, and I will put My words in His mouth, and He will tell them everything I command Him. Whoever will*

*not listen to My words, which He speaks in My Name (Yah-weh), I will judge him for it.”* – Deut.18:18

Are we to believe that the Hebrew Meshiakh was instituting the same forbidden detestable abominations as offered to the gods of Babylon? As we have discovered, the pagan nations practiced religious cannibalism as worship to their deities: Mithra, Dionysus, Osiris, etc. Their sacrifices included the “eating” the flesh and “drinking” the blood of these gods!

*“Do not think that I came to destroy (do away with - annul) the Torah Law or the Prophets. I did not come to annul, but to fulfill!”* – Matthew 5:17

If the Savior came to fulfill the Torah Law, as IT IS WRITTEN, WHERE in the Torah Law does Yahweh instruct His righteous people to drink blood and eat human flesh? It doesn’t! The Savior clearly stated He preached the Torah!

Did the Meshiakh come to teach that the Torah Law could be transgressed symbolically? That it is good to spiritually transgress? Would you bet your eternal life on it? It appears the Church has placed their bets on drinking blood.

*“We know that we belong to Yahweh, and that the whole world is under the control of the evil one.”*

– 1 Yahchanan/John 5:19

With the whole world under the control of the evil one, the same one who concocted the Gnostic forgeries and mistranslation of the New Covenant writings, now you are beginning to witness the depths of just how deceived and spiritually “drunk” the Church has become. Because of the forgeries, the Church actually believes that breaking the Torah Law and engaging in religious cannibalism will bring them heavenly blessings and eternal salvation.

*What Jew would  
tell another Jew  
to drink blood,  
even symbolic  
blood?*

## *Chapter 7*

# **Blood in the Levitical Covenant**

## *A Blueprint for the Meshiakh*

*“They serve at the tabernacle which is the blueprint and pattern of the heavenly things...For Yahweh said, See that you make all things according to the pattern shown you on the mountain.” – Hebrews 8:5*

Remember, Yahweh's very first judgment against Pharoah and the Egyptians was turning the Nile River (which they also worshiped) into blood, making it unfit to drink!

*“And Mosheh and Aaron did just as Yahweh instructed So he lifted up the rod and struck the water that was in the river, in the sight of Pharoah and in the sight of his servants. And all the waters of the river were turned to BLOOD. The fish that were in the river died, the river stank, and the Egyptians COULD NOT DRINK the water of the river. So there was blood throughout all the land of Egypt.” - Exodus 7:17-18 (also Ps.105:29)*

This is why Yahweh had the Nile River turned to blood, so as to make it UNDRINKABLE! Drinking blood does not benefit the physical body, nor the spiritual body! The instructions of the Torah Covenant are clear concerning the issue of blood. The Hebrew Savior was well aware of this.

## **“POUR OUT” The Blood**

When the Savior urges mankind to repent, what exactly is He telling all of mankind to repent of? Let’s look at the Torah Law and see what it says about the role of blood under the Levitical Covenant. The Levitical Priesthood was responsible for performing the required animal offerings upon the Tabernacle altar for the transgressions of the individual as well as the nation.

*“And indeed, we find that even the first covenant of Yahweh was not put into force without the shedding of blood. For when Mosheh had told the people every precept of the Law, he took the blood of calves and goats and with water, scarlet wool, and hyssop sprinkled both the Torah itself and all the people. Saying, This is the blood of the covenant which Yahweh commanded you. ... For to bind anything by the Law it must be purged with blood; so without the shedding (pouring out) of blood, there is no remission or forgiveness of transgressions.” – Hebrews 9:18-22*

There is specific instructions on how the blood must be handled for an acceptable offering to be made to Yahweh. In the consecrating of Aaron and his sons for service in the Tabernacle, the following instructions for blood were given:

*“You shall take the blood of the bull, and put it on the horns of the altar with your finger, and pour out the rest*

*of it at the base of the altar...then you shall kill the ram, and you shall take its blood and sprinkle it all around on the altar.” – Exodus 29:12,16*

Nowhere in all of chapter 29 do we see instructions for “drinking” the blood of the sacrificial victim for completing the ritual of consecration for service in the Tabernacle.

In the Book of Leviticus, sin offerings were also made for the Levitical Priesthood. Nowhere in all of Leviticus chapter 8 do we see Yahweh ever giving instructions to the people or the priests to “drink the blood” of the bull to be spiritually consecrated or be absolved of transgressions. Specific instructions for the blood were,

*“And Mosheh killed it. Then he took the blood, put some on the horns of the altar...to purify it; and then he poured out the blood at the base of the altar. So he consecrated it and made pardon for it.” – Leviticus 8:15*

In every instance where the life of an animal is taken to make reconciliation for transgression, the blood is “poured out” at the base of the altar onto the ground. It is always the Hebrew word #8210 shaphak’ meaning: to spill, gush forth or TO POUR OUT. “Shaphak” does NOT mean: to drink, ingest, or imbibe into the mouth or digestive system of man. Nowhere in all the Torah instructions do we find Yahweh instructing the Levitical priests to drink the blood of the animal offerings for sin. Why? Because it’s against the Law! The instruction of Yahweh is clear – the blood of an offering must always be “poured out” onto the ground –

*NOT into the one’s mouth!*

The pattern and blueprint for all righteousness is based upon the instructions and commandments of Abba

Yahweh as found in the Torah Law and the Prophets and confirmed by Yahsha the Meshiakh and His Apostles. The transgression of “eating or drinking blood” is the reason why Yahweh had to establish the Levitical system. Under this system of blood from specific animals, we were given a blueprint of the re-deeming role of the Meshiakh who “poured out” His blood to make pardon for the transgressor’s soul! The Torah Law states,

*“For the life of the flesh is in the blood, and I have given it to you upon the altar to make pardon for your souls; for it the blood that makes restitution for the soul. Therefore, I said to the children of Israel, No one among you shall eat blood, nor shall any stranger who dwells among you eat/drink blood.” – Leviticus 17:11-12*

“Drinking the blood” symbolically during the Christian ritual of Communion is one of the greatest deceptions of the Devil in the history of the world. Communion clearly transgresses the Torah Law of heaven. Without humble repentance and turning away from this Blood Cup of Mithra, there can be no pardon for this grievous sin, and no hope for eternal life!

## **Blood is NOT Food**

Drinking blood does not make pardon for one’s sins. Drinking blood symbolically does not make pardon for one’s sins. The blood of the Meshiakh makes pardon for the repentant man because it was “poured out” at the base of the altar, NOT because it is “holy food”. Blood is NOT food. Nowhere in the Torah Law does Yahweh give a pattern or blueprint for the “drinking of blood” to make pardon for one’s sins nor establish blood as a dietary supplement. The

same prohibition applies to blood from clean animals that are prepared as FOOD. Mosheh reminds the children of Israel against this carnal desire just before his death as they were preparing to enter the Promised Land.

*“When you cross over the Yordan River, and live in the land Yahweh is giving you to inherit...there will be a place Yahweh will choose to establish His Name, and there you will bring all that I instruct you: your burnt offerings, your tithes and special gifts, and all the choice things you have vowed to Yahweh... Nevertheless, you may slaughter your animals in any of your towns, and eat as much of the meat as you want...only you must NOT EAT the blood; you must pour it out on the ground like water.”* – Deut. 12:10-11,15-16.

The prohibition against eating raw uncooked bloody meat is first found in the very beginning long before the children of Israel heard Yahweh’s voice from Mt. Sinai. Genesis 9:4...

*“But you shall NOT eat flesh with its life-blood in it.”*

Yahsha the Messiah knew perfectly the Torah of Yahweh and the prohibition of eating or drinking of the life-blood. This is why He never would have instituted the Communion ritual as practiced by deceived Christians around the world.

This Christian world has been deceived because the New Covenant Scriptures were intentionally mistranslated by “deceitful scribes”! These mistranslations are the inspiration and work of the Devil through his earthly agents – the Gnostics of Mystery Babylon. Yahweh knew full well how gullible is mankind. He knew wicked men would “add to” and “take away” from His instructions and covenant (Deut. 4:2).

The Prophet Yeremyah/Jeremiah gave us warning in,

*“...Behold the lying pen of the scribes have mistranslated them and recorded them wrong!” – Yeremyah 8:8*

The carnal mind cannot improve upon the perfect plan of life ordained by the Creator. The mistranslations were intentional to deceive mankind into practicing iniquity, speaking blasphemy, breaking Yahweh’s seventh-day Sabbath, abandoning His Feast celebrations, as well as to practice religious cannibalism. All these abominations were conjured up from the rotten heart of *Mystery Babylon the Great!* This is why we are called to study and prove all things so we are not deceived in the Last Days (2 Tim.2:15; 1 Thes.5:21; Matt.24:24). What must we study? The Torah! How do we prove whether something is true? The Torah! What did the Prophets and Meshiakh teach? The Torah! The Torah explains,

*“For the life of the flesh is in the blood. It is the life of all flesh. The blood sustains its life. Therefore, I said to the children of Israel: You shall NOT drink the blood of any flesh...whoever eats of it shall be cut off.”*

- Leviticus 17:14

The Apostles even convened a special conference in Jerusalem to decide particular points in the Torah Law for the Gentile converts to obey. They included the prohibition against “eating the blood”. Acts 15:20,28-29 records,

*“For it was judged as righteous by the Spirit of Yahweh, and us, to put on you no more requirements, than those which are required in the Torah; such as that you abstain...from eating meats with the blood still in them”*



How many people do you know like to go out to a restaurant and have “a nice thick juicy steak”? In Christian cultures, most will request that their steaks be

cooked “rare” to “medium rare”. They equate tastiness and quality eating with the amount of blood that remains dripping from the meat! Yuk! *How do Christians like their meat of Jesus?* Medium rare? ...rare?...Oh, not cooked at all?! Just raw and bloody?

The Savior was blessed to understand and obey the “*every word that proceeded out of the mouth of Yahweh.*” (Matt.4:4). That “every word” includes NOT drinking blood!

Here is the record of the ancient Israelite army of King Shaul. The men of the army were caught “*red-handed*” eating the blood from the Philistine plunder,

*“After they had driven back the Philistines that day from Michmash to Aiyalon, the troops were very faint (from hunger). The people pounced on the plunder and took sheep, oxen, and calves – butchering them on the ground and eating them with the blood. Then they told this to Shaul, and said, Look, the people are transgressing the Law of Yahweh by eating with the lifeblood. Then he said, You have broken faith. Roll a large stone over here at once. Then Shaul said, Go out among the men and tell them: Each of you bring me your cattle and sheep, and kill them here, then eat them. Do not transgress against Yahweh by eating with the blood!...”*

– 1 Samuel 14:31-34

Instructions AGAINST **blood** are detailed in the following ref.: **Unger’s Bible Dictionary**, Moody Press, p.149 says,

**“Blood** (*Hebrew dahm; Greek haima, the circulatory life-fluid of the body*) ... 1. *As Food.* When permission was given to Noah to partake of animal food (Gen.9:4) the use/partaking of blood was strictly forbidden. In the Mosaic Law (of Yahweh) this prohibition was repeated with emphasis, ... (Lev.3:8; 7:26) ... *Because of the blood*

*the eating of bloody portions of flesh (Gen.9:4), or of flesh with blood (Lev.19:26; 1 Sam.14:32), is also forbidden. The penalty was that the offender should be “cut off from the people,” which seems to be death, but whether by the sword or by stoning is not known (Lev.17:14). This prohibition was also made by the apostles and elders in the council of Jerusalem, and coupled with things offered to idols (Acts 15:29) ... ”*

## **The Savior Fulfills the Torah and the Prophets**

*“Do not think that I have come to destroy-annul the Torah or the Prophets; I have not come to destroy, but to fulfill/establish them!” – Matthew 5:17*

The Torah remains the foundation of the Faith of the Savior. Yahweh’s righteous laws can never change, and this includes the Law against cannibalism (Ps.111:7-8; Mal.3:6). It was and remains sin & transgression to drink the blood of anything or ANY offering to Yahweh! As recorded by the eye-witness of His execution, Yahsha the Meshiakh fulfilled the Law and Prophets. His death on the tree (Deut.21-22-23) included His blood being “poured out” onto the ground...

*“However, one of the soldiers pierced His side with a spear, and immediately blood and water poured out.”*  
– Yahchanan/John 19:34

This fulfilled the Torah which we expounded upon earlier. It also fulfilled the Psalms and the Isayah 53:12, which say,

*“I am poured out (Heb. shaphak) like water, and all my strength has left me.” – Psalms 22:14*

*“because He poured out His life unto death, and He was*

*numbered with the transgressors, and He bore the sin of many, and made intercession for the transgressors.”*

There is no mention in any of the “Gospel” accounts of the disciples hurriedly gathering together below Yahsha’s bloody body (as He hung on the stake) ready with their cups to catch His dripping blood so they could drink it to fulfill some strange ritual He instructed the prior night.

If “drinking his blood” was required for eternal life, as we were taught to believe from Yahchanan 6:51-58, then why weren’t they trying to catch his real blood in a cup? Why do we NOT see His personal disciples catching and drinking His real blood - didn’t they want eternal life? Had they forgotten what the Savior of the world had said about His blood – unless you drink it, you have no life in you? Why do ALL the “Gospel” accounts omit any word about the Apostles missing this once-in-a-lifetime opportunity to catch in their “Holy Grail” His pure life-saving blood?

***It’s because the Savior NEVER SAID to “drink” His blood!***

***“Only you must not drink the blood, you must pour it on the ground like water.” – Deuteronomy 12:16***

If the Savior was fulfilling and magnifying a Law of Yahweh by telling His disciples to “*eat His flesh*” and “*drink His blood*” for everlasting life, then what particular command in the Torah Law was He referring to?? What prophecy was being fulfilled by His disciples as they performed a religious cannibalism service? In contrast, we can find prophecy that shows his ENEMIES “*eating his flesh*” – *NOT His disciples!*

*“When the wicked, even mine enemies and my foes, came upon me to eat up my flesh, they stumbled & fell.” - Ps. 27:2*

Yet, Yahchanan the Apostle (the “assumed author” of the cannibalism passages of Ch.6, vss.51-58) did record for

us that he witnessed the Savior’s blood “pour out” onto the ground! (re-read Yahchanan 19:34) This magnificent fulfillment of prophecy was also the cause behind the great earthquake (Matt.27:51) that shook the earth, tore the Curtain of the Most Qodesh Place, and when many of the dead came back to physical life (Matthew 27:51; Mark 15:38).

“Pouring out” the wine at the Memorial service is what the Savior instituted for all His disciples on the night previous to the Passover observance!

Let’s summarize the contradictions that we have so far observed in the Book of Yahchanan/John the Apostle.

1. Religious cannibalism is clearly found in vss.51-58 of chapter 6. From this sermon, we are led to believe that “*eating his flesh and drinking his blood*” is required for eternal life. *This breaks the Torah.*
2. There is absolutely NO record of the “Communion” ritual to be found. John’s “Gospel” is one of the longest and most elaborate witnesses to the personal instructions and commission given by the Savior. *How could the Apostle forget this most vital of all rituals required for the eternal life of all mankind?*
3. Yahchanan, an eye witness of Yahsha’s death, did record that the Savior’s blood did “pour out” onto the ground (19:34), fulfilling both the Law and the Prophecies concerning His death. If Ch.6:51-58 were true, then *why wasn’t John waiting with a cup to catch the blood of the Savior at the base of the stake?*

## The Cup of Demons

“...the things which the Gentiles sacrifice they sacrifice to demons and not to Yahweh, and I do not want you to have fellowship with demons.” – 1 Corinthians 10:20



The Communion contradiction and confusion is resolved when we REMOVE the Gnostic's forgery of vss.51-58 from Yahchanan/John 6! Doing this brings the writings into unity with the Torah-based teachings of the Savior. Removing the Gnostic's addition of cannibalism also helps us understand why the words: "eat" and "drink" cannot be found in Luke's version of events on that night before the Passover. Read it for yourself and see! (Luke 22:19-20).

*19. Then He took bread, and gave thanks, and broke it, and gave it to them, saying, This represents My body which is given/broken for you; do this in remembrance of Me.*

*20. In the same way, after the meal, He also took a cup saying, This cup represents the covenant in My blood, which is shed (Heb. shaphak: poured-out) for you.*

There is NO "eating" of the bread, NOR "drinking" from the blood cup! Luke was a Greek convert, and a highly educated physician. His "gospel" was originally penned in Greek. The theme of Communion cannot be found in His original Greek rendering. What more do you need? More proof you say? Surely...there's much, much more!

## *Chapter 8*

### **“The Flesh Profits Nothing”**

*“Are you so foolish? Having made a beginning in the Spirit of Yahweh, are you now trying to attain perfection in the flesh? ”* – Galatians 3:3

From the quotes by the Church Fathers, we witnessed that the Mystery religions exalt the physical “flesh” of the god which is required to be eaten to attain the qualities of the god...thus the flesh becoming an idol for worship. In sharp contrast, Yahsha the Messiah responded to such a concept by declaring that the flesh contains no redeeming power, no spiritual strength, only weakness and uselessness, saying,

*“Watch and pray, or you will be put to the trial. The spirit is truly ready and willing, but the flesh is weak. ”*  
– Mark 14:38

This is the purpose behind fasting. Fasting denies the flesh which empowers the spirit in man to overcome temptation to

sin and other weaknesses of the flesh. Throughout all of Scripture, the physical body contains no attributes for overcoming the devices of the devil. Temptations through the flesh is the Devil's choice target. While in the Garden of Gethsemane, the Apostles were overcome by their flesh's weakness for physical sleep during the Meshiakh's most pressing hour and trial of whether to follow through with the will of Yahweh, and submit to being murdered at the hands of Roman soldiers. The Savior scolded the Apostle's for the weakness of their flesh. (Matt.26:40-41)

The flesh is exalted and worshiped in many pagan religions. The Greeks were fond of worshiping the physical strength and physique of man. This gave rise to the Gymnasia and the Olympics – athletic events that glorify the flesh to please the gods of Greece, such as Zeus and Hercules.



Yet, King David the Psalmist (one of the strongest & most courageous warriors ever known) was inspired to write,

*“Yahweh takes no pleasure in the legs of a man.”* -Ps.147:10

In other words, Yahweh is not pleased by the physical strength of man's flesh. (Read also Zech.4:6b) Throughout all of Scripture, the flesh is NEVER symbolic of spiritual strength, but spiritual weakness. It is not symbolic of life, but sin, corruption and death! From the mouth of the Savior,

*“It is the Spirit that gives life, the flesh profits nothing.  
The words that I speak, they are Spirit and they are life.  
But there are some of you who do not believe...”*

– Yahchanan/John 6:63-64.

Yes, you just read it for yourself. Yet Christianity - almost

half the world's population - does NOT believe nor trust in what the Savior just said there! These are the very words which we must believe to have eternal life! Yahsha's flesh bore the curse of sin and was nailed on a stake.

Yahsha the Meshiakh's own words above contradict Church doctrine. The Messiah was absolutely clear here, "*the flesh profits nothing!*" Some versions have "*useless*!" The flesh is NOT sacred as you have been taught. It has NO REDEEMING VALUE – it is useless! Therefore, "*eating the flesh*" symbolized by bread or some circular wafer called "*the Host*" likewise "*PROFITS NOTHING*" for eternal life in the Salvation Plan of Yahweh!

In disbelief and disobedience to the true Savior, the Gnostic pagans believed just the opposite. They honored the sun-god Mithra whose "*flesh and blood*" did profit the pagan to attain *their version* of eternal life. "*Communion*" is the theology of Mithraism – not the Faith of the Savior of Israel.

This becomes the question: Does eternal life come through *the Hebrew Savior - Yahsha the Meshiakh*? Or does eternal life come through *the pagan sun-god Mithra*? The Eucharist or Communion is the "*Mass*" mind-control which all Churches are under – *the Mystery of Iniquity* – the Mystery of MITHRA! The idolatrous worship of "*flesh and blood*"!

*"Now I say brethren, flesh and blood cannot inherit the heavenly kingdom of Yahweh..."* – 1 Corinthians 15:50a

From the original lawful intent of Yahchanan/John 6, it is clear that the Bread coming down from heaven - which the Savior referred to was the Word of Yahweh – the Torah Law and Prophets! The Spirit of Life is found in this bread - the Word of Yahweh as taught by His beloved Son Yahsha,

*"the Words that I speak,  
they are Spirit and they are life"* – ch.6:63b

*“He who rejects Me, and does not accept My words, has One Who judges him. The word that I have spoken, the same will be used to judge him in the last day. For I have not spoken of My own; but Abba Yahweh who sent Me gave Me the commandments of the Torah Covenant – what I should say and what I should speak. And I know that His Torah commandments are life everlasting; so whatever I speak, I am saying exactly what My Abba has told Me to say.”* - Yahchanan/John 12:48-50

Yahsha taught and spoke the Torah Law to Israel – the true bread of life! He repeatedly expressed the redeeming value of the Word – the Law and Commandments (Matthew 4:4).

Mosheh prophesied that the Messiah would come in Yahweh’s Name to teach the spirit of the Torah to the people in order to see the power of Yahweh. (Deut.18:18-19) He did not add to it or take anything away from it.

*“And behold, one came to Him and asked, Teacher, what righteous thing must I do, so that I can have eternal life? But He said to him, Why do you question Me about righteousness? There is only One who is the standard of perfection, and that is Yahweh; so that if you would enter into life – Keep the Torah Law!”*

– Matthew 19:16-17

Keeping the Torah’s Commandments includes not engaging in ritual cannibalism! This includes NOT drinking the blood, nor trusting in – much less “eating” human flesh! The Savior repeatedly expressed the non-redeeming value of flesh when it came to the Kingdom of Yahweh.

The inspiration of Yahweh, His truth and revelation did not originate with or from human “flesh and blood”!

*“When Yahsha came into the region of Caesarea*

*Philippi, He asked His disciples, saying, Who do men say that I, the Son of Man, am? They said, Some say Yahchanan the Immerser, some Eliyah, and others Yeremyah, or one of the prophets. He said to them: But who do you say I am? Then Shimon Kepha (Peter) answered, and said, You are h'Meshiakh, the Son of the living Abba. Yahsha answered, and said to him; Blessed are you, Shimon son of Yahnah, for FLESH & BLOOD has NOT revealed this to you, but My Abba who is in heaven.” – Matthew 16:13-17*

The previous verses are once again *anti-Communion*. The Pope and his priests of the Roman Catholic Church would disagree with the Savior by saying, “*the divine is revealed through the Eucharist!*” That is the official written statement of doctrine from the Catechism and official writings of the Roman Church as well as Protestant doctrine! But again, the Hebrew Savior is NOT who they worship! They follow the rituals and worship of the sun god-Mithra, Dionysus, Osiris, Tammuz, Adonis, and Baal!

Notice the powerful truth contained in the next scripture reference. Even the Israelite Apostle Yahchanan/John understood the truth that the revelation of Yahweh is not found in the “flesh and blood” symbols of any Eucharist or Christian Communion. To Catholics, the following verse is heresy or “anathema” to the concept of the Eucharist!

*“But as many as accepted Him, to those He gave authority to become the children of Yahweh—to those who believe in Yahweh’s Name—Who are begotten, NOT of blood, NOR of the will of the flesh, nor of the will of man, but of Yahweh.” – Yahchanan/John 1:12-13*

As seen above, there is NO necessity for the Communion ritual in order to become the children of Yahweh!

The Apostles words were clear! Shaul - the converted Pharisee and expert in the Torah - expressed this same anti-Eucharist sentiment to the Galatian congregation saying,

*“To reveal His Son within me, so that I might preach Him among the heathen/pagans, I did NOT immediately confer with (the) flesh and blood.”* – Galatians 1:16

The Apostle Shaul confirmed the Messiah’s teaching that the flesh *profits nothing*, going so far as to declare that the flesh brings *DEATH* – not life! Shaul understood the struggles of the flesh to overcome the temptations of selfishness and transgressing the Torah. This is why the flesh in any form: physical, spiritual, metaphor, symbolic can never please Abba Yahweh, because it has no benefit to men.

*“...the flesh is subject to the law of sin.”* – Romans 7:25

*“...He condemned sin in His flesh; in order that the righteous requirements of the Torah might be fully performed in us, who do not live according to the flesh, but according to the Spirit of Yahweh. For those who live according to the flesh, set their minds on the things of the flesh; ...So then, those who are of the flesh cannot please Yahweh. But you are not of the flesh, but of the Spirit of Yahweh”* – Romans 8:3-5,8,9a

In the following incredible verse, Shaul compares “flesh and blood” with utter corruption!

*“Now I say this brothers, that flesh and blood cannot inherit the Kingdom of Yahweh, neither does corruption inherit incorruption!”* – 1 Corinthians 15:50

The flesh brings death. The Apostles confirmed that the

flesh contains no redeeming value. The Savior condemned the sins of man in His own flesh, and this is why He did NOT exalt any physical or symbolic “flesh” to celebrate or eat. The Savior knew that the bread even in symbolism of His flesh – if it were eaten with this in mind - was and remains religious cannibalism - an abomination to Yahweh!

*“If you live according to the flesh, you will DIE; but, if through the Spirit of Yahweh, you put to death the works of the flesh, you will live.” – Romans 8:13*

*“I say then, Walk in the Spirit of Yahweh, and you will not perform the lust of the flesh; for the lusts of the flesh are against the Spirit of Yahweh;...for the works of the flesh are obvious, which are these: adultery, fornication, uncleanness, licentiousness, godworship, sorcery, hatred, contentions, evil jealousies, rage, selfish ambitions, dissensions, heresies, envy, murders, drunkenness, revelries, and the like, of which I warn you beforehand, ...that those who practice such things will not inherit the Kingdom of Yahweh.” – Galatians 5:16-21*

After reading this, who in their right mind would desire the works of “the flesh”? *Bloodthirsty cannibalism* would fit quite nicely into this chapter of Galatians as a “*lust of the flesh*”. How then could eating “flesh” bring about righteous character? The Apostles – all righteous witnesses of the Hebrew Savior - taught directly AGAINST the pagan concepts of a “redeeming flesh and blood” doctrine, or Communion! But Christians still lust to partake of the flesh!

An unmistakable pattern is portrayed throughout both the “Old” and “New” Covenants that flesh is symbolic of sin, corruption and death! It has never had any redeeming value to insure one’s eternal life! As the Savior of the world said,

*“...the flesh profits nothing!”*

## The Savior MAGNIFIED the Torah

*“Yahweh is well pleased, for His righteousness’ sake, to magnify the Torah, and make it honorable.”*  
– Y’shayah/Isayah 42:21

If real physical flesh and blood CANNOT inherit the Kingdom of Yahweh, then how can “symbols” of flesh and blood bring one to inherit the Kingdom of Yahweh? They can’t! This breaks even the Spirit of the Law! No one can argue that the Savior’s ministry was to magnify the righteousness of the Torah, and this, in effect, made the Torah more binding than ever before!..for He said,

*“You have heard that it was said by the people of ancient times: You shall not commit adultery; But I say to you: Whoever looks on a woman with lust for her, has already committed adultery with her IN YOUR HEART.”*

- Matthew 5:27-28


This same magnification of the Torah applies to murder, idolatry, covetousness, theft, even eating human flesh and drinking blood! If you even “think in your heart” to perform cannibalism – with symbols such as bread and wine – you are committing cannibalism! This is the magnification and spirit of the Torah Law. This is the sin of Communion.



*“You shall not drink the blood...” – Leviticus 17:14*

Yahweh’s will and desire for mankind is not vague and mysterious as Christianity and its Gnostic Church Fathers want you to believe. The truth of the matter is...

*Communion is Baal Worship!*



## *Chapter 9*

### **Clues from the New King James Version**

*“...Yahsha will bring to light all things hidden in darkness,  
and will reveal the secret intentions of men’s hearts...”*

– 1 Corinthians 4:5

From the Preface of the New King James Version, we find the following admissions to human error in transmitting translations. Consider these words carefully, for they concede to the fact of the pagan scribe’s carelessness in maintaining original purity and thought from the Hebrew authors, (probably because they were Mithraic sun worshipers and not committed to the Torah Law of Yahweh).

It appears that the author of the Preface is trying to downplay the errors, variations, and mistakes made by the pagan translators. Could this be a cover so we won’t think to question the authenticity and accuracy of the doctrine of Communion? or say “the Trinity”, or the mistranslations allowing the eating of unclean foods, or Rome’s changing of

the 7<sup>th</sup>-day Sabbath to Sunday? Notice the following “facts” vs. “opinions” marked in parentheses:

***“The New Testament Text***

*...Minor variations in hand copying have appeared through the centuries, before mechanical printing began about A.D. 1450 (fact).*

*Some variations exist in the spelling of Greek words, in word order, and in similar details (fact). These ordinarily do not show up in translation and do not affect the sense of the text in any way (opinion).*

*Other manuscript differences such as omission or inclusion of a word or a clause, and two paragraphs in the Gospels (fact), should not overshadow the overwhelming degree of agreement which exists among the ancient records. (opinion). ” - Preface, NKJV, p.viii.*

These admissions are significant and should NOT be overlooked. The light of truth must be shined upon “all things hidden in the darkness!” It plainly confessed that these pagan scribes “added “ words, clauses and whole paragraphs IN THE GOSPELS! Couldn’t such “minor” revisions cause readers to adopt the same religious ideas as the pagan translators – religious scribes who were reared from childhood in the pagan doctrines of Roman Empire! They certainly were not the righteous and obedient servants of Yahweh!

Would we be so foolish to assume that the pagan “scholars” - who were committed to the popes, priests and gods of the Roman Empire - were never anti-Semitic, but absolutely committed to preserving the Torah-based religion of some Messianic Jews? Sir William Tyndale – the English Reformer from Oxford University was burned at the stake by the Catholic Church for attempting to preserve the NT from Catholic corruption. There is plenty of evidence that the early “fathers” of the Catholic Church hijacked the NT writ-

ings for one purpose only – to create a whole different religion than that expressed by the Hebrew Savior, and to give the Communion of Mithra credibility and world-wide acceptance.

The “Center Column (*margin*) Notes” of the NKJV will give powerful evidence and confirmation that the words “eat” and “drink” were later added to Greek texts known as the TEXTUS RECEPTUS or Received Text (*the traditional text of the Greek-speaking Asian Churches – founded by the “Church Fathers”*) of which the King James “NT” is based. This will be shown to you in just a moment, but first some very enlightening information again from this same Preface,

*“In the late nineteenth century, B. Wescott and F. Hort taught that this text (the Receptus) had been officially EDITED by the fourth-century Church... (this would have been around the time of the Constantine’s Council of Nicea wherein citizens of the Roman Empire were officially ordered to observe the pagan customs of Mithraism under the new name of Catholic Christianity) ... Since the 1880’s most contemporary translations of the NT have relied upon a relatively few (two) manuscripts discovered chiefly in the late nineteenth and early twentieth centuries... the Codex Vaticanus and Codex Sinaiticus, because of their GREATER AGE. The Greek text obtained by using these sources and the related papyri (our most ancient manuscripts) is known as the ALEXANDRIAN TEXT.... Another viewpoint of NT scholarship holds that the best text is based on the consensus of the majority of existing Greek manuscripts. This text is called the Majority Text.... Most of these are in substantial agreement... their readings are verified by... QUOTATIONS from the EARLY CHURCH FATHERS... The Majority Text is SIMILAR to the TEXTUS RECEPTUS... ”*

From these admissions in the Preface, we see that the unreliable, Mithra-worshiping Gnostic “Church Fathers” were the ones responsible for hijacking and altering the Apostle’s writings to reflect the Catholic ritual of Communion! They conceived the Textus Receptus, whereas the Alexandrian Text was NOT contaminated by these Gnostics, and therefore, does NOT contain the Communion forgeries!

Here comes more proof! The Center-Column Notes of the NKJV give a “NU-Text” designation wherever significant variations occur in the various (NT) Greek manuscripts, textual notes are classified as follows:

**NU-Text - These variations from the traditional text (Textus Receptus/Majority Text) generally represent the Alexandrian or Egyptian type of text described previously...They are found in the Critical Text published in the twenty-sixth edition of the Nestle-Aland Greek New Testament (N) and in the United Bible Societies' third edition (U), hence the acronym, “NU-Text”.**

- Preface, NKJV, p. ix

Remember, the **Alexandrian Text** (composed of the Codex Vaticanus and the Codex Sinaiticus) is the oldest manuscript of the NT. Any “variations” are due to the edited inclusions found within the Majority Text (Textus Receptus) of the Church Fathers. For the most accurate translation, we are desperately looking for Center Column margin notation, “NU-Text”. Again, the 1611 King James Version as well as the “New King James Version” are both written from the Majority Text (which contains the Gnostic’s additions, fraudulent passages, clauses, and uninspired words.) The beauty of the NKJV is that it gives us the desperately needed information/margin notes to identify the Gnostic’s forgeries.

## Evidence from Mark 14:22

With that, let's take a look at the margin notes in the Book of **Mark**, chapter 14, verse 22,

**22.** *And as they were eating, (Yahsha) took bread, blessed and broke it, and gave it to them and said, 'Take, <sup>1</sup>eat; this is My body.'*  
[margin note: 22 <sup>1</sup>NU-Text omits eat]

The oldest Greek Alexandrian Text of Mark does NOT contain the most vital word of the Communion ritual - “eat”! That’s powerful evidence, wouldn’t you say? What a blessing to have found this evidence for Yahweh’s people. Upon the necessary removal of the word “eat” from verse 22, the account of Yahsha’s Memorial in the Book of Mark now stands in agreement with Luke’s account in Luke 22:19-20,

*“And He took bread, gave thanks and BROKE it, and gave it to them, saying, ‘This is My body which is given for you, do this (break the bread) in remembrance of Me. Likewise He also took the cup after supper, saying, ‘This cup is the new covenant in My blood, which is shed (poured out) for you.’”*

Of all the Bible versions published and printed in the past 2,000 years, their *sacred* words, “eat” and “drink” are NOWhere to be found in ANY version of the “Gospel of Luke”! It was this glaring omission that first alerted me to this massive religious conspiracy by Mystery Babylon!

*“There is a conspiracy of her prophets in her midst, like a lion ravening the prey: they have devoured souls...Her priests have violated My Torah, and have profaned My qodesh things...”* – Ezekiel 22:25-26

## More Evidence from 1 Corinthians 11

The Apostle Shaul expressed that his understanding of “Yahsha’s Memorial” came personally from the Savior. This is shown in his first letter to the Corinthian congregation,

*“For I received from Yahsha that which I also delivered to you; that the Messiah Yahsha on the same night in which He was betrayed took bread,”* (v.23)

Now let’s examine the Apostle Shaul’s understanding of “Communion” from **1 Corinthians**, chapter 11, verse 24:

**24.** *and when He had given thanks, He broke it and said, <sup>1</sup>Take, eat; this is My body which is broken for you; do this in remembrance of Me. ’*  
[margin note: 24 <sup>1</sup>NU-Text omits Take eat]

Wow! Another reference that reveals the corruption of the Gnostic’s Textus Receptus/Majority Text! Here again, the Alexandrian source maintains the purity of Yahsha’s Memorial wherein cannibalism is NOT found. Shaul is NOT one of the original Apostles who sat down with the Savior on that particular night. Shaul’s version of events came by the resurrected Savior personally! This is objective evidence from outside the “Gospel” record – powerful evidence that agrees with both Mark’s version, as well as Luke’s!

*This is the unity we have been looking for!*

## Additional Clues: 1 Corinthians 10:16

The following verses speak of the fellowship of the children of Yahweh with participating and sharing in the sufferings and death of the Meshiakh of Israel. This is the context of the verse. Nowhere in the following verse can

you find the words “eat” or “drink”. Because the early Gnostics FAILED to add these vital words into this 1 Cor. passage, as they had done elsewhere, the King James translators of the 17<sup>th</sup> century were pressured to maintain the cannibalistic theme and used the English word “communion” instead of “sharing in”, “participating in”, and/or “fellowshipping in”...the sufferings of the Savior. The margin notes of the NKJV reveal the mistranslation of 1 Corinthians 10:16

**16. *The cup of blessing, which we BLESS, is it not the <sup>1</sup>communion of the blood of Meshiakh? The bread which we BREAK, is it not the <sup>1</sup>communion of the body of Meshiakh?***

**[margin note: 16 <sup>1</sup>fellowship or sharing]**

When one “breaks” the bread, as the Savior taught, the disciple is acknowledging sharing in the physical sufferings for Faith and loyalty to Him. “Sharing in” His sufferings was the theme of v.16 - *NOT* the cannibalism ritual of “Communion”. This is another reason why the pagan translators of the King James I cannot be trusted. Since “eat” and “drink” were obviously NOT IN THE ORIGINAL GREEK TEXTS, they had to mistranslate the Greek word *koinonia* (Strong’s Concordance#2842 meaning: *partnership, i.e. (lit.) participation or (social) intercourse*). The word “communion” is a blatant misrepresentation in order to preserve the cannibalism theme for Mithraic Communion. These are the slick tricks of pagan propaganda – mistranslating to mislead the reader into preconceived deceptions and false doctrines of ancient Baal worship and pagan practice.

“Communion” is the most sacred doctrine of the Church. *Eating and drinking* the “flesh and blood” symbols is taught to place the Christian worshiper in direct “spiritual fellowship” with “the LORD”! Church pastors, evangelists, priests and missionaries RAISE UP their Golden blood-Cup

of “Christ” to initiate all new converts, and it’s all based on a Lie! - *Utter fraud* rooted in an ancient ritual honoring the abominable Sun-god Mithra. That’s what “blind faith” gets you – sin and death! (Romans 6:23)

*“My people are destroyed for lack of knowledge.  
Because you have rejected knowledge of My Torah Law,  
I will also reject you, that you will be no priest to Me...”*  
– Hosheyah 4:6

### **The Aramaic (NT) PESHITTA Version**

The Aramaic Peshitta version is the official bible of The Holy Apostolic Catholic Assyrian Church of the East. The name Peshitta in Aramaic means "Straight", for it is said to be,

*“the only authentic and pure text which contains  
the books in the New Testament that were written  
in Aramaic, the Language of Mshikha (the Messiah)  
and His Disciples.”*

After a thorough search of the Peshitta Communion accounts, I discovered to my astonishment, that the word “eat” was ALSO omitted in the Peshitta’s Book of Mark, just as we had discovered in the NKJV! More confirmation!

#### Facts from the “Gospel” records of the Peshitta version:

- The Book of Marqus (Mark) 14:22, the vital word “eat” is nowhere found! (Agreement with the Alexandrian Text)
- The words “eat” and “drink” are nowhere found in the Book of Luqa (Luke)
- Communion is nowhere found in Yukhanan (John)

In reference to the originality of the Peshitta, the words of “His Holiness” Mar Eshai Shimun, Catholicos Patriarch of the Church of the East, are summarized as follows:

*“With reference to....the originality of the Peshitta text, as the Patriarch and Head of the Holy Apostolic and Catholic Church of the East, we wish to state, that the Church of the East received the scriptures from the hands of the blessed Apostles themselves in the Aramaic original...”* [www.peshitta.org](http://www.peshitta.org)

According to the Torah Law, at least two or three witnesses are necessary to establish and confirm any matter. (Deuteronomy 19:15) Communion: eating the bread as the “flesh” of the Savior CANNOT therefore be established as sound doctrine even from the gospel record of their so-called “original” Aramaic Peshitta.

This Peshitta NT is touted as the “official Bible” of the Catholic Church in the East, but yet, they follow all the pagan doctrines of Rome, including the Eucharist of Mithra. Watch how Rome tries to justify this abomination by claiming “aramaic originality”. In reference to the Aramaic, the Latin Patriarch Maximus at Vatican II, said:

*“Christ, after all spoke in the language of His contemporaries. He offered the first sacrifice of the Eucharist in Aramaic, a language understood by all the people who heard Him. The Apostles and Disciples did the same and never in a language other than that of the gathered faithful.”*

The Latin Patriarch’s statements are obviously the Church’s Eucharist propaganda, because the same revelations exist in the Peshitta as revealed by the New King James Version. If they so trust in its “originality”, then why don’t

they see that the Peshitta does NOT support the Communion doctrine! Three out of four gospel records show NO eating of “the bread”! Likewise, the words of cannibalism of the “Communion” account in the Matthew – Peshitta must also fall under the same scrutiny of doubtful origins! It is therefore certain that the Aramaic Matthew-Peshitta was NOT an authentic original from any of the Hebrew Apostles, but most likely a later translation off the Greek Gnostic forgeries. I also reject the Peshitta as the “original hand of the Apostles” because those who ascribe to the Peshitta dismiss the heavenly inspiration behind the Book of Revelation...*the only Book personally delivered by the Savior Himself from heaven in the language of heaven - Hebrew!*

Nowhere in the NT Books of Mark, Luke or Yahchanan/John does the Savior ever instruct His disciples to “eat” the bread that symbolized His body. This is powerful evidence verifying the scholar’s astute commentary from The Anchor Bible shown in chapter 5. Yahchanan/John 6:51-58 is a hoax, and there is no basis for the words “eat” & “drink” and why we are finding so much evidence and confirmation that “eat” and “drink” were indeed later added into Greek texts by false scribes and false “Gnostic” apostles, known as the “Church Fathers”!

What about the Communion account of Matthew? After seeing the admitted forgeries in both Greek, Aramaic and English translations of the “Gospels”, why should we doubt Matthew’s account as also being forged at some point in time? All the Apostles are in **disagreement** with Matthew. Again, ONE witness is not enough to establish a doctrine (Matt.18:16), especially to establish some “new” doctrine that is clearly “perverting” the foundation of the faith, the Law of Yahweh which forbids any form of cannibalism.

*“...there are some who trouble you, and are trying to pervert the message of Meshiakh”* – Galatians 1:7

## Symbolic Cannibalism Condemned in 1 Corinthians 11!

The NKJV has been an incredible source of facts for our expose’. Chapter 11 of 1 Corinthians contains another admission that helps us see the truth that the Apostle Shaul actually condemned the “eating and drinking” of the symbols Yahsha instituted to remember His death! It is probably the most powerful wooden-stake into the heart of this blood-drinking vampire called Communion. Let’s look at how this divisive issue is addressed by the Torah-teaching Apostle,

*“...Now in giving these instructions I do not praise you, since you come together not for the better but for the worse. For first of all, when you come together as a family, I hear that there are divisions among you, and in part, I believe it. For there must also be factions among you, that those who are approved may be recognized among you.”* Vss.17-19.

The issue begins with acknowledging that some false doctrine had crept in and was causing “division” (or two opposing “factions”) within the congregation when they “came together”. What usually draws the congregation together is a Sabbath or Yahweh’s annual Feasts. The words, “*Those who are approved...*” means those KEEPING the will of Yahweh (and what better way to find out who stands for Yahweh’s Law then for a false doctrine to pop up!), and the opposing faction were those teaching AGAINST the Torah. Shaul recognized that this was a dispute over doctrine which was NOT according “to the Law and the Prophets” (Isayah 8:20). Communion had been a pagan ritual long before the Hebrew Savior was even born! The majority of the Corinthian congregation had been converted from pagan occultism, where blood-drinking rituals were prime tradition. Most of the Corinthians grew up “drinking the blood cup” of

the god Dionysus – the god of wine. Someone in the congregation was trying to convince the others that it wasn't sin to "eat and drink" the symbols of "flesh and blood". Some people just can't break old pagan habits! It appears that the Apostle Shaul had already been informed of the situation which was causing division. He then cuts right to the matter!

*"Therefore, when you come together in one place,  
this is NOT TO EAT the Lord's Supper!" – v.20*

This verse has NOT been altered in any version of the New Covenant writings nor Greek translations in the past 2,000 years! From Shaul's quick retort, the "division" was obviously over whether "to eat" Yahsha's Memorial or to "NOT eat" Yahsha's Memorial. Without beating around the bush, Shaul corrected the conflict immediately and thus confirmed all our previous research, evidence, facts and Torah-based evidence that "Yahsha's Memorial" is NOT a ritual of eating and drinking! The bread symbolizing His body is NOT for eating, and the wine symbolizing the blood of the Messianic covenant is NOT for drinking!

The righteous of the congregation must have been glad to receive Shaul's doctrinal clarification hopefully to resolve a major conflict and restore unity back to the new congregation. Shaul chastises those who were eating the symbols, declaring in shock,

*"What?! Don't you have your own personal homes in  
which to eat a meal and get drunk in?..What shall I say  
to you? I do not praise you, for you should be ashamed  
of yourselves!" – v.22*

Yes, regarding the symbols of Yahsha's flesh and blood as FOOD is indeed a shameful and sinful doctrine. Shaul clearly said that their meal and drink should have been fulfilled

before they came together for Yahsha’s Memorial, so that NO eating of “the Body of Messiah” would ever take place.

Shaul also pointed out that because many were “feasting on” these symbols before everyone arrived, the bread (for “breaking”) and the wine (for “pouring out”) was no longer available for all members of the congregation to partake in once everyone has arrived and assembled on the night before the Passover (v.22).

Therefore, Shaul is teaching against the most widely accepted and most sacred tradition of both Catholic and Protestant Christianity: Communion. “Yahsha’s Memorial” is NOT food, and is NOT to be eaten.

### **More KJV Corruption – “*in an unworthy manner*”**

Now, I will continue with Shaul’s instructions for “Yahsha’s Memorial” using the English translation of the NKJV, but removing (appropriately) the cannibalism verbs “eat” and “drink” since the earliest Greek texts, as the evidence has clearly shown, never contained such verbs.

With all this evidence piling up, we should now present a more accurate translation that follows the Torah-based example of the Savior’s teaching. Instead of “eat” we will follow the example of the Meshiakh and insert “break”, as He did. Instead of “drink” we will follow the example of Meshiakh and insert “pour out” for this is what He did! By doing this, we will have unity and conformity with the “Gospel” accounts in the Books of Mark and Luke.

*“23. For I received from the King Yahsha the Meshiakh that which I also delivered to you; that Yahsha the Meshiakh on the same night in which He was betrayed took bread;*

*24. and when He had given thanks, He broke it and said, Take and **break** it for this is My body which is broken*

*for you; do this (break bread) in remembrance of Me. '*

*25. In the same manner He also took the cup after supper, saying, 'This cup is the new covenant in My blood. This do, as often as you pour it out, in remembrance of Me.*

*26. For as often as you break this bread and pour-out this cup, you proclaim the manner of My death until He-Meshiakh returns.*

*27. Therefore, whoever eats this bread and drinks this cup (<sup>1</sup>*in an unworthy manner*) will be guilty of the body and blood of the Meshiakh.*

*28. But let a man examine himself, and so let him break the bread and pour-out the cup.*

*29. For he who eats and drinks (<sup>1</sup>*in an unworthy manner*) eats and drinks judgment (KJV-damnation) to himself, not discerning the Meshiakh's body.*

*30. For this reason many are weak and sick among you, and many sleep (are dead).*

*31. For if we judged ourselves (according to the Torah Law), we would not be judged.*

*32. But when we are judged we are chastened by Yahweh, that we may not be condemned with the world (which participates in religious cannibalism).*

*33. Therefore, my brethren, when you come together (for Yahsha's Memorial), wait for one another.*

*34. But if anyone is hungry, LET HIM EAT AT HOME, lest you come together for judgment... "1 Cor.11:23-34a*

**[margin note: 29 <sup>1</sup>NU-Text omits *in an unworthy manner*]**

[v.27 also contains this fraudulent edition and should be omitted to hold uniformity of thought (emphasis mine).]

This blaring admission in the NKJV margin notes for v.29 is what will bring down the Christian world as we know it!

## “Damning” Evidence Revealed

You have just seen the incredible NEW evidence that should bring every Christian to their knees! Deception is the manipulation of words, and 1 Corinthians 11 is overflowing! The scholars behind the NKJV offered to tell us that the phrase “*in an unworthy manner*” was not found in the earliest Greek manuscripts! In effect, “*in an unworthy manner*” had been later ADDED INTO the Greek translations of verse 29 of chapter 11. This chapter was addressing the sin of “eating and drinking” the memorial symbols! The Church Father’s edited into their Greek text “eat” and “drink” in vss 24 and 25 (commonly found in the Majority Text). In order to maintain this hoax and their propaganda of religious cannibalism, they ALSO HAD TO manipulate vss. 27 and 29. Without this phrase, DAMNATION is clearly the theme.

This phrase was PURPOSELY inserted by the false scribes of Mithra – Gnostics of Mystery Babylon to maintain the Communion theme which now prevailed and was the result of the ADDED words “eat” and “drink”. The fraudulent phrase “*in an unworthy manner*” (or “unworthily” in some versions) INSERTED into v. 29 (and v. 27) makes any reader “think” that “*eating and drinking*” Communion is truly being taught and upheld, and that those partaking of these symbols must do so *in a worthy manner*. Symbolic cannibalism can never be performed “in a worthy manner”!!

Because this phrase “*in an unworthy manner*” was later ADDED, to be honest to Yahweh and men, we must REMOVE it! Without this edition, we find the original context will again agree with the accounts in Mark and Luke. (*Remember, the Preface to the NKJV admitted to the existence of these unfounded alterations to the Greek texts!*)

By correctly REMOVING this fraudulent addition “*in an unworthy manner*” from both vss.27 and 29, we now find the original intent and warning of ***severe judgment and***

**DAMNATION** as the penalties for “eating and drinking” the symbols of Yahsha’s body and blood! Why? Because the Apostle is warning the congregation of Yahweh’s righteous judgment for practicing the Mithraic bloodfest of Babylon!

Verses 27 and 29 of 1 Corinthians 11, should read,

*“...for he who eats and drinks  
eats and drinks **DAMNATION** to himself...”*

***DO YOU WANT TO BE DAMNED?!***



The Apostle Shaul warns Christianity,  
**You are DAMNED**  
**When you “eat and drink” Communion!**

The wages of cannibalism (sin) is death (Romans 6: 23), and this is why many of them were “*weak, sick, dying, and dead*” (v.30) because they did not judge whether their deeds were lawful or not! Violating the spirit of the Law is the same as violating the letter of the Law, ie. DEATH! If cannibalism wasn’t against the Torah Law, then how could simply eating physical bread and drinking wine cause such adverse physical conditions including death?! Because even violating the Torah Law in symbolism (of course) breaks the spirit of the Law! Eating and drinking Communion is cannibalism and sin! Communion brings damnation from heaven!

1 Corinthians 11 is clearly speaking of the “flesh and

blood” symbols known as “Yahsha’s Memorial”. Shaul makes this distinction again at the end of his exhortation advising that anyone who is hungry for a meal should fulfill that desire at home (v.34). We should never call “Yahsha’s Memorial” by the terms: “Communion” “the Eucharist”, or the “Last Supper”, because these labels IMPLY a meal for eating. These false terms just reinforce the mind-control.

Verse 26 of 1 Corinthians 11 tells us that “Yahsha’s Memorial” is our reminder of HOW the Savior died. He didn’t die by cannibalism! The righteous of Yahweh, for nearly 2,000 years have been oppressed with these false doctrines and lies of Babylon - a conspiracy to appease pagan gods with premeditated paganism and mistranslations!

Without exposing these grievous mistranslations within the NT, how could the true Hebrew Faith of Yahsha the Meshiakh ever be restored? Let’s rejoice that the Spirit of Truth is being “poured out” in these last days of religious corruption and abomination being practiced by the Church!

### Queen “Bloody” Mary I



Because of her deceit, corruption, arrogance and outright murder of Yahweh’s obedient servants and getting “drunk on the blood of the saints”, Yahweh gives this blood-drinking Whore a sure prophecy of fiery judgment!

## *Chapter 10*

### **Conducting a True Memorial of Yahsha's Death**

*“But the hour is coming...when the true worshipers  
will worship Abba Yahweh in spirit and in truth;  
for Abba Yahweh is seeking such to worship Him”*  
– Yahchanan 4:23

Yahsha the Savior did not die by being eaten to death in a cannibalistic orgy of flesh and blood. From all the evidence, we can conclude that the bread symbolizing the body of the Savior was NOT presented to be eaten, but ONLY to be BROKEN! Also, the cup of wine symbolizing the “blood of the (new) covenant” was NOT presented to the Apostles to be drank, but ONLY to be “poured out”.

Based upon a scripturally-accurate, Torah-based and factual foundation as presented in early chapters, Two Witness Ministries and The Remnant of YHWH have restored a true memorial service as closely performed almost 2,000 years ago by the Messiah, His Apostles and the first century Messianic synagogues. Our hope is that you have come to

realize a clear pattern of conspiracy and errors perpetrated against the Torah-based Apostolic writings to maintain the ancient pagan traditions of Mystery Babylon.

Two Witness Ministries hopes you can use the following outline to conduct your next “Yahsha’s Memorial” service. This memorial service takes place on the night BEFORE the Passover Feast of Unleavened Bread.

## **1. A Regular Meal**

*“Now before the Feast of Passover... ”* - Yahchanan 13:1

Many churches and congregations confuse the “Last Supper” as being the Passover – *this is incorrect*. The passage clearly states “BEFORE the Feast of Passover”. The actual Feast of Passover is the following night after sunset beginning the 15<sup>th</sup> day of Abib – 24 hours after “Yahsha’s Memorial”.

On this night before Passover, Yahweh’s people must gather together after sunset beginning the 14<sup>th</sup> day of the first moon Abib. Yahweh’s new year begins in the springtime – not in the Fall. So we first sit down and enjoy a delicious home-cooked meal, giving thanks and appreciation for the righteous fellowship between Yahweh’s people who have gathered to remember the historical significance of this night.

## **2. The Footwashing Service**

Then, after a regular meal, we prepare ourselves to wash each other’s feet, following Yahsha’s example of true brotherly love and service. We then read the following,

*“He got up from supper, and laid aside His royal tallit, then took a towel and tied it around Himself. After that, He poured water into a basin, then began to wash the*

*disciple's feet, and to wipe them with the towel that He had tied around Himself.”* – Yahchanan/John 13:3-4

Fix your wash basins with warm water and everyone have their own towel. If there is a large number of people present, just choose a couple of partners and take turns washing each other's feet. Even the children have fun here washing feet, but you will have to remind some of the more excitable youth, “*No splashing!*” It was not a regular Israelite custom for masters or heads of houses to wash a servant's feet, so Yahsha was giving the humble example that all are to be servants to each other, not considering yourself higher than any other. After the footwashing service, read the following,

*“After He had washed (all) their feet, He put His royal tallit back on, and sat down again. Then He said to them Do you understand what I have done for you? You call Me Master, Teacher and Leader, and rightly so, for that is what I am. Since I then, your Leader and Teacher, have washed your feet, you are also bound in obligation to wash one another's feet. For I have given you an example, that you do as I have done for you.”*

– Yahchanan/John 13:12-15

This was also the night Yahsha was also betrayed by Judas Iscariot - who pretended to be His servant. Yahsha, knowing who would betray Him, actually washed Judas' feet before commanding him to leave on his mission of betrayal,

*“...Then Yahsha said to him; What you are going to do, do quickly!...then he (Judas Iscariot) having accepted the piece of bread, immediately went out; and it was night.”* – v.27,30

If you want, you can certainly read more of the words

of the Savior as recorded by Yahchanan, but he was the only Apostle to record this particular footwashing ceremony.

### 3. The Marriage Cup

After the foot washing ceremony, Yahsha gave a lengthy discourse to His disciples about true love and service to Yahweh and each other, from Yahchanan/John chapters 14 thru 17. He spoke words of encouragement and comfort. You should read some of these passages with your gathered friends before sharing in the ceremony of the Marriage Cup.

This wine cup represents the coming wedding to take place in the near future. After the King returns, He will drink this Marriage Cup with His 144,000 faithful who were just resurrected (or “born again”) into YHWH’s eternal family and Kingdom (Revelation 14:1) Yahsha’s first miracle was turning water into wine at a marriage feast! (Yahchanan 2:1-11) This first cup is known symbolically as the “Marriage Cup” signifying the marriage vows of loyalty and love that a bride makes to her groom. Luke recorded the following,

*“And when the hour had come, He sat down and the twelve apostles were with Him. Then He said to them: With longing I have wanted to eat this upcoming Pass-over meal with you before I suffer, But I say to you: I will not eat of it, not until it is performed in the Kingdom of Yahweh! Then He took a cup, and gave thanks, and said: Take this, and share it among yourselves, for I say to you: I will not drink of the fruit of the vine (wine), not until the Kingdom of Yahweh comes!” – Luke 22:14-18*

The Marriage Cup is a wine cup (Heb. *yayin*) that is shared by all who experienced immersion in Yahsha’s Name. On this night, after the meal, this is the ONLY cup that is partaken by His disciples. This is the first cup, and it is NOT

referred to as “the blood of the new covenant!” This is NOT the “blood” cup! It is simply the “fruit of the vine” - a wine cup shared that seals the loyal commitment and righteous relationship of Yahweh’s righteous people to the Savior and Redeemer of their soul! This separate cup is also confirmed in the Books of Matthew 26:29 and Mark 14:25. (No other ministry except Two Witness Ministries understands the significance of this *first cup* – the Marriage Cup!) Those who remained obedient unto the end will share this Marriage Cup with Yahsha the King at the future Feast of Tabernacles – *the Wedding Supper of the Lamb* - following His majestic return on Yom Teruah. He will return on the first day of the seventh moon (Ethanim 1) a full 3-1/2 years AFTER the “Son of Perdition” takes his position in a rebuilt Catholic – Masonic-Illuminati-New Age temple in Jerusalem at a future Passover! *This anti-Messiah will drink from a Golden Cup!*

#### 4. **The Bread** - Symbolizing His Body (*do not eat!*)

*“Then He took bread and gave thanks, and broke it, and gave it to them, saying: This represents My body which is given for you; do this (breaking of the bread) in remembrance of Me”* – Luke 22:19

By “breaking the bread” each person should get the feeling of being responsible for His death. (*This is a loaf of leavened bread symbolizing His body bearing sin – and also, unleavened bread could not be eaten yet for the Feast of Unleavened Bread had not yet begun.*) That is why each person has their own piece of bread “to break”. As an action of His own freewill, Yahsha h’Meshiakh offered His body for Yahweh’s people who desire forgiveness, mercy & eternal life,

*“For it is not possible that the blood of bulls and goats could take away sins. Therefore, when He came into the*

*world, He said, ‘Animal sacrifices You did not want, but a body You have prepared for Me...Then I said, Behold, I have come in the Volume of the Book IT IS WRITTEN of Me to do Your will, O Yahweh...’* – Hebrews 10:4,5,7

*“..Not My will but Yours be done Yahweh”* – Luke 22:42

## 5. The Blood Cup - of the New Covenant (*do not drink!*)

*“In the same way, after the meal He also took a (wine) cup saying, This cup represents the Covenant in my blood, which is shed (poured-out) for you.”* – Luke 22:20

The English word “shed” found in all King James versions is Greek word #1632- *ekcheo* and is the exact equivalent to the Hebrew *shaphak* – to pour out. Nowhere in any version or translation of the Book of Luke on earth do we see the “Communion” words “eat” or “drink”! The Hebrew-speaking Savior used the Hebrew word *shaphak* here for “poured-out” (translated “shed” in the English KJV) just as was used by the Prophets. We remember HOW He died,

*“He poured out (Heb. *shaphak*) His soul to death...”*  
– Y’shayah/Isayah 53:12

*“I am poured out (Heb. *shaphak*) like water,  
and all My strength has left me.”* – Psalms 22:14

At “Yahsha’s Memorial”, Yahweh’s people “pour out” the wine (symbolizing His blood) onto the ground, for this is what His blood literally did! Since the ceremony usually takes place indoors and we don’t want to make a total mess and stain everything with the wine, each of the participants can “pour out” their individual wine cup into a “community bucket” or large bowl set on the floor. This can later be taken

out and poured onto the ground by one of the elders.

Until Yahsha returns, the Savior wants His disciples of every generation to remember HOW he died. The Christian tradition of Communion does not teach HOW the Savior fulfilled the Torah Law and the Prophets. On the Preparation Day for the Passover – the 14<sup>th</sup> day of Abib, He laid down His life! 



This shows that not only was the Inquisition a monstrous evil in and of itself, it has left a legacy of horror that is unmatched. All the repressive systems of whatever flavor that have ever been imposed on the suffering masses of the world have owed their inspiration to the Office of the Inquisition.

The Nazi Gestapo and secret police everywhere, including the Soviets, Saddam and the Shah, CIA mind-control experiments, McCarthy's Red Scare, Mao's Red Guards, the Khmer Rouge, certain aspects of the War on Drugs and the shameful abuse and torture of prisoners at Abu Ghraib, Gitmo, and elsewhere, *all* utilized techniques pioneered by those most-devoted servants of "Holy Mother Church". In the latter years of his reign, the Holy Office of the Inquisition, now called the Sacred Congregation for the Propagation of the Faith, was headed by orthodoxy-czar Cardinal Josef Ratzinger, now Pope Benedict XVI. It once again became responsible for dealing with the worldwide clergy abuse scandal, for John Paul II transferred all those cases involving desecrating the Eucharist or buggering altar boys back to its jurisdiction once again. It still ferrets out errant priests, but until the recent round of crises, its chief interests seemed to be seeking out the theologically treacherous ones. For those who threaten the faith have always been considered a graver menace than those who endanger the bodies of young believers.

It will be very interesting to see whether the new pontiff will use his power to silence dissenters or oust abusers. Yet the signs are not good. It was [recently reported](#) that

in 2001, then-Cardinal Ratzinger signed a letter sent to all bishops, asserting the Church's right to hold secret inquiries and keep the evidence confidential for 10 years after the sexually-abused victims reached adulthood under pain of ex-communication. This continued the **policy of secrecy** confirmed by "good" Pope John XXIII in the secret instructions on **Crimes of Solicitation**. Despite the hopeful spin in the press accompanying the start of his reign, the outlook is very grim under Benedict XVI – former head of the Inquisition.
